(b) Security on Indo-Pakistan border has been tightened further.

Percentage share of taxes in Government spending

770. SHRI YASHWANT SINHA: Will the Minister of FINANCE be pleased' to state:

- (a) whether the percentage share of taxes in Central Government's spending in the last five years has declined and the per centage share of borrowings and deficit' financing has increased;
 - (b) if so what are the reasons tfigfefor;
- (c) whether it is a desirable or undesirable trend; and
- (d) iri case the trend is undesirable what steps Government propose to take in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF EXPENDITURE IN 'THE MINISTRY OF FINANCE (SHRI B. K. OADHVI): (a)-The share of tax receipts in the total expenditure Of the Central Government was 42 ,per cent in 1984-85. It fell to 41 per cent in 1986-87, but in 1987-88 (RE) as well as 1988-89-(BE) it has increased to 43 per cent. The share 'of borrowings and deficit financing was 22 per cent in 1984-85. It increased to 26 per cent in 1986-87 but has come down to 24 per cent in 1987-88 (RE) and 1988-89. (BE).

(b) to (d) Details of variations in tax receipts, borrowings, etc. are shown in the Budget documents of respective years. It has always been the endeavour of Govern ment *to* maximise revenues and reduce wasteful and inessential, expenditure.

Violation of FERA'by Mr, Win Chadhaaha Mr. Harsh Chadha

- . (c) whether Mr. Anil Kumar of* the Directorate of Enforcement contacted Mr. Win Chadha in USA in December, 1987 and if so, what was the [purpose and with what results?

THE MINISTER OF STATE fN THE DEPARTMENT OF 'ECONOMIC AFFAIRS IN THE MINISTRY OF JFTN- ANCE (SHRI EDUARDO FALEIRO): (a) Shri Harsh Chadha was not arrested either by Directorate of Enforcement or CB.I. His statement was however, recorded by Directorate of Enforcement on bis arrival in India.

- (b) The passports of Shri, Win Chadha and Harsh Chadha were revoked at the request of the Enforcement, Directorate. -Shri Harsh Cfaadha's passport was impounded on his arrival in New Delhi on 18-3-88. Shri Chadha was given a duplicate passport *to* enable him to come to appear before the Joint Parliamentary Committee.
- (c) Investigations under FERA against Shri Win Chadha are still in progress. It would not be appropriate to discuss details of the investigation.
