(b) The Seminar-cum-Workshop made several recommendations with an emphasis on the ways and means of dealing with operation and maintenance problems faced to SAARC member countries in the field of rural water supply. The member countries have not drawn any joint action plan.

Advanced U.S. AWACS for Pakistan

- *167. SHRI SURESH KALMADI: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether it is a fact that the United States of America is supplying more advanced AWACS to Pakistan; and
- (b) if so, what is the reaction of Government thereto?

MINISTER OF STATE IN THE THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) The US Government is committed in principle to supply an Airborn Early Warning system in Pakistan. No decision has been announced about the type of system to be supplied; nor about the modality and timing of the transfer.

(b) On several occasions, Government has conveted to the US Government India's serious concern at the supply of sophisticated arms to Pakistan, particularly those which act as force multipliers. Government considers that such supplies results in an unnecessary and wasteful arms race in the sub-continent and thereby highten tension in the region.

 - (c) No, Sir.
 - (d) Does not arise.
