- (e) whether Win Chadha and Harsh Chadha were wanted by Government in this period for violation of FERA?

STATE IN MINISTER OF OF EXTERNAL MINISTRY THE NATWAR K. AFFAIRS (SHE Chadha SINGH): (a) Shri Hersh tendered celrtain documents carried by film to the Enforcement Directo. rate under Section 40 of FERA Act. documents contained These 1973. photocopies of page No. 1 to 7, 34 to 36 of Shri Win Chadha's passport issued by the Consulate General of India, San Francisco, on 8.6.1987.

- (b) These pages do not bear any entry regarding Shri Win Chadha's travel.
- (c) and (d) According to entries in his passport, Shri Hersh Chadha entered USA in June, 1987, and January, 1988. Some other visas are affixed on his passport without any entry details.
- (e) S/Shri Win Chadha and Hersh Chadha were required by the Enforcement Directorate for investigation undor FERA Act and for appearance in the Court of Additional Chief Metropolitan Magistrate, New Delhi.

Extradition of Win Chadha

1065. SHRI LAL K. ADVANI: SHRI ASHWANI KUMAR:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether Shri Win Chadha is not a Green Card holder in U.S., if so, whether Government have initiated move for his extradition in order to initiate proceeding against in India for FERA violations;

- (b) if so, what is the progress in this regard; and
 - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHEI K NATWAR SINGH): (a) to (c) According to information made avilable by the US Government recently, Shri Win Chadha does not hold a Green Card.

Government examined the possible lity of initiating extradition proceedings. However, Shri Win Chadha has since returned to India on 14.4.88.

OF STATE IN THE MINISTER PERSONNEL. THE MINISTRY OF PUBLIC GRIEVANCES AND THE MINISTER SIONS AND MINISTRY IN THE STATE HOME AFFAIRS (SHRI P. CHIDAM-BARAM): (a) and (b) According to the available information, there were 26 posts of chief executives in central public enterprises vacant as on 20th April, 1988. The dates since when these posts have been vacant, undertaking-wise are given in the enclosed Statement (See below). This does not include the posts of chief executives which are kept in creat**ed** yance or which are newly

ones and where the Public Enterprises Selection Board is yet to make its recommendations.

(c) In view of the procedural for-

malities, it is not possible to indicate specifically the dates by which the vacancies are likely to be filled up. However, recruitment action to fill up these vacacies is under way.
