THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI SHIVRAJ PATIL): Thj.s information is not available as no order has so far been placed on any manufacturer for the shell of Bofors gun.

Dejure recognition of Israel

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI K. NATWAR SINGH): (a) Yes, Sir.

- (b) India has not establishes diplomatic relations with Israel and has accordingly not opened an Embassy Oj1 Consulate in that country.
- (c) and (d) Government are not aware of any harassment or delay in il'f grant of visas to Israeli citizens seeking to visit their relatives in India. A special procedure has been derised for the issue of visas to Israeli citizens of Indian origin. The policy and Procedure in this regard jg under constant review.

Missions to Mars

These discussions are in a very preliminary stage.

(b) There are no plans for an Indian landing On Mars, as the ex-

plorations are unmanned scientific studies.

Fire at Central Ordnance Depot, Jabalpur

- 1043. SHRI D. B. CHANDRE GOWDA: Will the Minister of DEFENCE be pleased to state:
- (a) whether clear evidence of terrorists have come in light in sabotaging the Central Ordnance Depot, Jabalpur on March 23, 1988;
- (b) if so, whether any further investigations have since been made to fmd out the exact cause of sabotage: and
- (c) by when committee the to probe pointed by Government circumstances will submit report and what action Government propose to take in this regard?
- THE MINISTER OF STATE IN THE (SHHi MINISTRY OF DEFENCE SANTOSH MOHAN DEV). (a) There was no immediate evidence of sabotage by terrorists.
- (b) A Court of Inquiry has already been ordered to ascertain the Jeause of fire and to go into other important aspects of the incident. Another investigating agency has also gone into the matter.
- (c) The Inquiry is likely to be completed during this month and the report is expected thereafter. Further action will depend on report of the Court of Inquiry.

delegation to the 11th session of the U.N. Commission on Human Settlements. During his stay in Delhi, he called on Prime Minister. As this wag purely a courtesy call no official discussions were held or decisions taken on bilateral matters.

(c) and (d) Yes, Sir. Government were surprised at the unilateral issue of a press release on informal exchanges during a private courtesy call on the Prime Minister. Further, the press release had quoted our Prime Minister selectively, out of context and inaccurately.
