(a) whether an advertisement was given by the Indian Oil Corporation at Ahmedabad for the award of SK.. LDO dealership, if so, whether applicants were called for interview before the Oil Selection Board;

(b) when were the interviews held and what was the result thereof and whether the same was communicated to the concerned applicants;

(c) how many applicants appeared before the Oil Selection Board and the details of the applicants who qualified for the said dealership; and

(d) whether it is a fact that the advertisement was given on the 8th January, 1985 and the formalities are still pending and if so, what are the reasons therefor?

' THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM. AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) Yes, Sir. The Indian Oil Corporation released three advertisements for the award of SKO-LDO dealerships at Ahmedabad on the 30th July, 1983, the 23rd July, 1984 and the 8th January, 1985;

(b) The interviews for the above were conducted by the Oil Selection Board (West) on the 17th October 1984, the 10th August 1985 and the 10/11th February, 1986 respectively. The Letter of Intent was issued to one Shri Hiralal Chunilal Shah against the interview held on 17-10-84. In. regard to the interview held on 10-8-85, the oil company received the final panel from the OSB(W) ton 2G-9-85, but due to receipt of a comp-

laint LOI could not be issued. The selection against the interview held on 30/1-3-86 has been finalised. The oil company concerned will issue the LOI accordingly;
