THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA ROHATGI): (a) It is estimated that the end of the Seventh Plan, there would be a peacking

shortage of about 9, 400 MW of power in the country.

(b) In 1987-88, hydel generation was affected. adversely in various States, including Andhra Pradesh, Kamataka and Kerala; due to low reservoir levels. The power generation during 1987-88 in these three States was as follows:—
