- (a) whether it is a fact that his Ministry has received complaints in regard to high prices of finished medicines based on Ethylstrenol, Nandrolone, Phenyl Propionate and Decanoate;
- (b) if so, what are the details thereof and action taken thereon;
- (c) whether it is a fact that the producers of these drugs have exceeded the prescribed profitability limits as per Form No. 6 submitted under DPCO, 1979;
- (d) whether Kelkar Committee has been informed of these facts; and
- (e) if so, what are the details thereof?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO); (a) to (e) A_B per the provisions of

Drugs (Prices Control) Order 1987, formulations of Ethylstrenol, Nandrolone, Phenyl Propionate and Decanoate are not under price control and the manufacturer of decontrolled formulations are free to revise the prices. However, Government is keeping a watch and intervenes, wherever necessary.
