Production of gas during the same year was 11.42 billion cubic metres which exceeded its requirement.

Award of tender for south basin gas field development project near Bombay

1326. SHRI YASHWANT SINHA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that the ONGC invited global tenders for its Bharat Petroleum Gas process complex of the South Basin Gas Field Development Project near Bombay:
- (b) whether it is also a fact that the bid made by Hyundai Heavy Industries was technically suitable and financially also it was the lowest;
- (c) whether the award of the project was made to Snamprogetti of Italy incurring an extra expenditure of about Rs. 14 crores; and
- (d) if so, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) Yes, Sir.

(b) to (d) The lowest evaluated offer on cash basis was made by Mis. Hyundai Heavy Industries, South Korea. The contract was however, awarded to Mis. Snam Progetti, Italy as their offer was found to be cheaper after taking into account the mixed credit offered by the firm alongwith their offer.

LPG agencies in Uttar Pradesh

1327. SHRI SHANTI TYAGI: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) what is the total number of LPG agencies in Uttar Pradesh;
- (b) whether Government have received requests from various quarters for allotting more agencies to the State; and
- (c) if so, whether Government propose to accede to their demands?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) As on the 1st April, 1988 there were 336 LPG distributorships in operation in the State of Uttar Pradesh;

- (b) Yes, Sir.
- (c) Upto the Marketing Plan 1987-88, the Oil Industry has planned to set up 104 more LPG distributors-ships in Uttar Pradesh which are at various stages of processing.

Finding of crude oil off Goa coast

1328. SHRI JOHN F. FERNAN-DES: Will the Minister of PETRO-LEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that there is a rich find of crude oil off Goa coast;
 - (b) if so, what is its exact location;
- (c) what is the estimated quantum of crude oil in the area; and
- (d) by when ONGC propose to start drilling the wells there?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) to (c) Area off Goa Coast is a part of Kerala-Konkan basin. Three wells, namely, Cochin-I, Kasarged-I and Karwar-I, which were drilled in this basin during 1978-80, proved dry. Drilling of another well namely Cochin High-I has since been completed and the well is under testing.

The basin is under exploration and the quantum of likely crude production will be known only after successful exploratory results.

(d) Presently there is no such plan.

Use of natural gas available in godavari basin for production of electricity

1329. DR. NARREDY THULASI'REDDY: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether there is any proposal under Government's consideration for utilising available natural gas in Godavari Basin for the production of electricity in Andhra Pradesh;

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) to (c) 0.4 MMCMD gas has been committed for the gas based power plant proposed to be set up by the APSEB.

Setting up of a regional office of ONGC in Andhra Pradesh
