**Technical posts in the department of
Chemicals**

(a) how many technical posts exist in the Department of Chemicals;

(b) whether these posts were to be-filled on deputation basis;

(c) how many posts have been filled on regular basis and what arrangements have been made to ensure that an incumbent does not stay on the post for more than three years; and

(d) how many technical posts are lying vacant and since when and what steps have been taken to fill up the-same?

THE MINISTER OF INDUSTRY (SHRI J. VENGAL RAO): (a) The total number of sanctioned non-ministerial posts is 31.

(b) The method of recruitment prescribed/proposed in the Recruitment Rules envisages filling up of the posts by composite method of promotion/ deputation /transfer/ direct recruitment.

(c) and (d) Out of 31 sanctioned non-ministerial posts, 1 have been filled up on regular basis, 2 by *ad-hoc* arrangements and the process of recruitment to the rest Of the 13 vaca-
