- (c) Exports of cotton yarn are allowed with a view to improve the utilisation of spindleage capacity and to earn foreign exchange

Administration concerned. report regarding weapons of service pattern/prohibited bore and weapons

of civil non-prohibited bore not quired by the State Police Forces is required to be sent to the Headquarters for their instructions for disposal of such weapons.

#### Decline in the expert of F.C.U. Tobacco

1594. DR. YELAMANCHILI SIVA-JI: Will the Minister of COMMERCE be pleased to state:

- (a) whether there has been a decline in the export of F.C.U. tobacco:
- (b) if so what are the reasons. therefor and what remedial measures have been taken by Government in . the matter?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R. DAS MUNSHI): (a) Yes, Sir.

- (b) The reasons for decline in the export of tobacco are the worldwide slowing down of demand and particularly reduced offtake by USSR of our tobacco. The steps being taken to boost the export of tobacco are:
  - to China — Exports of tobacco have been permitted ton D.A. terms (Documents against Acceptance) with the time stipulation being 30, days within which collection would be made after discharge of cargo at the post of destination.
  - -Exports of tobacco to Egypt have been permitted with payment terms involving 50 per cent against presentation of documents on shipment and balance 50 per cent on arrival of goods after inspection in Egypt.
  - -Exports to Egypt and Algeria have been permitted by extension of one year credit.
  - -A delegation comprising of the representatives of the Ministry of Commerce/Tobacco Board/STC
