THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJJT PANJA): (a) to (c) The Income Tax department conducted 2122 searches at various places in India, during the period between 1st January, 1988 to 31st March, 1988 wherein prima-facie unaccounted assets amounting to approximately Rs. 5656.39 Iacs were seized besides incriminating documents indicating tax evssion. The persons searched have, in their statements at the time of searches, admitted concealment of income to the tune of Rs. 8553.70 lacs. In view of the large number of cases involved, it is not practicable to furnish further details as soufifat.
