Incident of tigress bite In Delhi zoo

Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

(a) whether it is a fact that a case of biting by a tigress has recently taken place in the Delhi Zoo;

(b) if so, what are the details in this regard;

(c) whether adequate security arrangements are not available in the Zoo;

(d) whether it is also a fact that First Aid Facility is also not available at the Zoo; and

(e) if so, what steps are being taken to provide necessary medical facilities at the Zoo in the event of any mishap?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI Z. R. ANSARI): (a) and (b) Yes, Sir. On 20-3-1988 a child named Nitin crossed the protective railing of the White Tigers enclosure and put his right hand through the bars into the enclosure. The white tigress which had cubs, charged and bit off the child's hand close to the shoulder. The child was

taken to the All India Institute of Medical Sciences for treatment.

(c) Security arrangements are adequate.

(d) and (e) First aid for minor cases of injury is provided in the Zoo. However, major cases like the one which occurred on 20-3-1988 cannot be handled at the Zoo and have to be handled at appropriate hospitals.

(d) the reasons for abandoning them?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRIMATI KRISHNA SAHI): (a) and (b) 8 major and 30 medium projects are under implementation in the Seventh Plan. Of these, 2 major and 15 medium projects are expected to be completed during the Seventh Plan period.

(c) and (d) The State Government have not reported abandoned of any project as such.
