(b) to (d) All worn connected with the settlement of displaced persons in the Kondagaon ond Paralkote zones of the Dandakaranya Project having been completed, it was decided to transfer the office of the FA&CAO from Jagdalpur (Madhya Pradesh) to Koraput (Orissa), the headquarters of the Dandakaranya Project. The decision has been taken after careful consideration of administrative efficiency and convenience and in the larger public interest. Movement of Government employees from one station to another in the discharge of their duties is one of the accepted exigencies of service.

(b) During the period from 1985 to 1988, the development of wastelands in Orissa has been done through affo-retation 20-Point Programme incorporates Centrally Sponsored Schemes of Forestry Sector, Rural Development, State Non-Plan and Plan Schemes¹ including Exter nally aided Orissa Social Forestry Project and schemes implemented with institutional assistance by the State Forestry Corporations. The achievement of afforestation during the period is 3.26 lakhs hectares.
