THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) The All India Kendriya Vidyalaya Teachers Assocition have, in their charter of demands, suggested inter alia, the following:—

- (i) Increase in internal promotion quota to 75 per cent in general and special promotional avenues for WETs, PETs, Drawing Teachers; Music Teachers, Librarians, Home Science Teachers, Lab. Assistants and guarantee of 3 promotions in career.
- (ii) Grant of time bound selection grade to all categories of teachers i.e. after 8 years, and introduction of super selection grade.
- (iii) PGT_S may not be posted on promtion outside the region as well as language area.
- (iv) Vice-Principals on promotion may be posted in another region and not in another language area.
- (b) Joint Consultative Machinery for the Kendriya Vidyalaya Sangathan has been constituted and it is the appropriate forum for discussions between the Kendriya Vidyalaya Sangathan and the associations. For matters concerning the management within the Kendriya Vidyalaya Sangathan the Board of Kendriya Vidyalaya Sangathan considers the issues and takes necessary decisions.

Disparity in pay scales of music teachers in Kendriya Vidyalayas, Navodaya Vidyalayas etc.

- (c) whether All India Kendriya Vidyalaya Teachers Association has demanded parity in this regard; and
- (d) if so, what is the reaction of Government thereto?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRT L. P. SHAHI): (a) and (b) The pay scales of Music Teachers in Kendriya Vidyalayas, Navodaya Vidyalayas and Schools under Delhi Administrations are as under:—

Kendriya Vidayalayas: Rs. 1200-30-1560-EB-40-2040 (For teaching music as co-curricular activity upto class VII)

Navodaya Vidyalayas: Rs. 1400-40-1600-50-2300-EB-60-2600

Delhi Administrations (i) Rs. 1400-40-1600-50-2300-EB--60--2600. (For Music Teachers teaching in secondary classes) (ii) Rs. 1640-60-2600-EB-75-2900 (For Music Teachers teaching in Senior Secondary classes).

- (c) All India Kendriya Vidyalaya Teachers' Association has demanded special grade for music teachers.
- (d) Since Music is taught as a cocurricular activity, it has not been considered necessary by the Kendriya Vidyalaya Sangathan to appoint Music teachers in a higher scale of pay.

(c) and (d) All India Kendriya Vidyalaya Teachers Association demanded that Vice-Principals on recruitment/promotnon may be posted in another region but not in another language area. Joint Consultative Machinery of the Kendriya Vidyalaya Sangathan is the appropriate forum for consultation between the Associations and the Kendriya Vidyalaya Sangathan and such changes as deemed necessary are considered by the Board of Governors of the Kendriya Vidyalaya Sangathan for decision.
