Returning of sculptures by national Museum, New Delhi to ABI

1791. SHRI MOTURU HANJMANTHA RAO: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state by when the National Museum, New Delhi propose to return the sculptures that were loaned by the Archaeological Survey of India, New Delhi between 1880 and 1984?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): Of the 34 art objects taken on loan from Archaeological Survey of India between 1980 and 1984, National Museum has already returned 15 art objects to Archaeological Survey of India. Out of remaining 19 art objects six are proposed to be returned during May, 1988. The decision with regard to the remaining 13 art objects has yet been taken.

(a) The National Policy on Education 1986 has recommended integration of components related to the building of National character and teaching of moral values among children in curriculum for schools. These have been incorporated in the curriculum developed by NCERT for Classes I to X.

(b) The teachings of Mahatma Gandhi in achieving a sense of oneness in the country as also other components of national integration are a part of the curriculum at the school stage. These have also been incorporated in the new curriculum developed by the NCERT.
