Railway Projects in Orissa

- (a) whether Government have received any proposal for construction of new Railway lines from the Government of Orissa during the 1985—88;
 - (b) if so, the details thereof;
- (c) what action has been taken by Government on each of these proposals;
- (d) whether Talcher-Sambalpur Railway project in Orissa is to be completed shortly;
 - (e) if so, by when; and
 - (f) if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) and (b) Government of Orissa has been suggisting construction of following new railway lines:

- (i) Jakhapura-Banspani
- (ii) Talcher-Sambalpur
- (iii) Korapur-Rayagada
- (iv) Khurda Road-Balangir
- (v) Bargarh-Raipur
- (vi) Amagura-Kesinga
- (vii) Talcher-Bimalgarh
- (viii) Gopalpur-Berhampur
- (ix) Jeypore-Malkanagiri
- (c) (i) Jakhapura-Daitari section of Jakhapura-Banspani line has been completed.
- (ii) Construction of Talcher-Sambalpur line has been taken up and is being progressed according to availability of resources,

- (iii) Construction of Korapur-Rayagada line has been accorded high priority for completion.
- (iv) Survey for Khurda Road-Balangir line has been completed. There is, however, no proposal to take up its construction at present due to constraint of resources.
- (v) For the other lines, no action could be taken due to constraint of resources for construction of new rail lines.
- (d) to (f) Completion of Talcher-Sambalpur line will depend on availability of resources in the coming years.

Construction of Daitary-Jakhapura-Banspani Line in Orissa

1684. SHRI KANHU CHARAN LEN-KA; Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that Government have stopped construction of Railway project Daitary-Jakhapura-Banaspani line in Orissa;
- (b) if so, what are the reasons therefor; and
- (c) by when is the work to be restarted?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) to (c) Construction of Daitari-Banspani line has not been taken up due to non-materialisation of anticipated traffic on Jakhapura Daitari section which was earlier opened for goods traffic. Construction of Daitari-Banspani line is now being examined by the concerned Ministries as a part of the project for export of Iron Ore to Korea via Paradip Port.

Electrification of Kharagpur-Bhubaneswar-Khurda Railway Line in Orissa

1685. SHRI KANHU CHARAN LE-NKA: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether any proposal is pending for clearance with the Railways regarding the electrification of Railway-line between Kharagpur-Bhubaneswar-Khurda in Orissa;

- (d) if the answer to part (b) above is in negative, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) No, Sir.

- (d) Electrification being capital intensive is being undertaken only on high density routes. The traffic density in Kharagpur-Bhabaneswar-Khurda being low, electrification is not justified at present.
