The Scientists working at the Voctor Control Research Centre, Pondicherry have succeeded in isolating and identifying an active metabolite-Cyclosporine from a fungal isolate. This compound is used as an immunosuppressant to prevent rejection phenomenon graft-operation. It is an expensive drug and is imported into India. Efforts are underway for commercial production of cyclosposive. As and when it is achieved, it would be possible for the Indian Pharmaceutical firms to enter the world market.

### STATEMENT BY MINISTER.

1. Correcting the reply given in the Rajya Sabha on the 16th March, 1988 to a supplementary to starred question 303 regarding new airports in the country.

MINISTER OF THE HEALTH AND FAMILY WELFARE AND THE MINISTER OF CIVIL AVIATION (SHRI MOTI LAL VORA): Madam Deputy Chairman, during the change of Supplementaries arising No. 303 out of Starred Question answered on 16.3.88, this House was inter alia informed that there only four international airports in the county and for declaring the fifth one approval of the Parliament will be obtained.

The correct position in the matter is that under section 1(3) of the International Airports Authority Act, 1971, the Central Government may, by a notification in the official gazette, apply the provisions of International Airports Authority Act to any other (New) aerodrome whereat international air transport services are operated or intended to be operated with effect from such date as may be specified in the notification. It follows, therefore, that Central Government is competent to declare any air-

port as international airport without seeking prior Parliamentary approval.

DR (SHRIMATI) SAROJINI MA-HISHI: Madam, I would like to have some clarification from the Minister. The Central Government is competent to declare any other airport as international airport the Minister was kind enough to say. We are not questioning the competence of the Central Government. We would like to know whether the Central Government considers Trichar the the Banaras Airport and such other airports where international aircraft are also landing and taking off, as international airports, whether they go along the rules and regulations and whether there are sophisticated equipment which are necessary for making an international airport.
