## Development of Chilka Lake as a tourist spot

**KANHU** CHARAN' 2239. SHRI LENKA: Will the Minister of TOURISM be pleased to state;

- (a) what are the names of the tourist spots to be developed in and around the Chilka Lake in Orissa;
- (b) what is the Government programme for desilting the Chilka lake;
- (c) whether Government are aware that the surroundings of the Chilka lake can be turned into a Marine Drive of the East: and
- (d) if so, what is the Government's programmes in this regard?

THE MINISTER OF . STATE IN THE MINISTRY OF TOURISM (SHRI GIRIDHAR GOMANGO): (a) IdentifL cation of tourist spots, assessment of requirement of infrastructure and formulation of projects to meet the requirement, are done by the State Governments. The Central Ministry of Tourism provides financial assistance to States for creation of tourism infrastructure on the basis of rpecific proposals received from the State Governments. On the basis of proopsals received from the Govt, of Orissa, the Mnistry has sanctioned the following projects for Chilka lake and the tourist spots around it: -

- (i) Motor Yacht for Chilka lake;
- (ii) Boat for Chilka lake;
- (iii) Water Sports at Chilka lake;
- (iv) Yatri Niwas at Satpada.
- (b) The Chilka lake is one of the wetland echo ssytems selected for conservation under the Wetland Programme of the Ministry of Environment and Forests, Government of India. The State Government of Orissa have also constituted a Steering Com-mittee for Wetlands in Orissa.
- (c) and (d) The Central Ministry of Tourism provides financial assistance

to States for creation of tpurism infrastructure at various tourist centres 'on the basis of specific proposals received from the State Governments provided the project falls within the purview of the approved plan schemes of the Ministry. Marine Drives, roads, etc. do not fall under any approved plan scheme of the Ministry.
