- (d) whether the State Government of Maharashtra have registered them as Veterinary practitioners; and
- (e) if so, wfieftier Government propose to amend the Veterinary Council Act, 1984 to register such nongraduate?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE COOPERATION IN MINISTRY OF AGRICULTURE (SHRI SHYAM LAL YADAV): (a) to (c) The Indian Veterinary Council Act, 1984 fully safeguards the duties responsibilities of veterinary and field assistants/stock assistants and such other non-graduate personnel as they can render Minor veterinary services under the supervision and "direction of registered veterinary practitioners. As such veterinary services in rural areas will not be affected.

- (d) Many States have their own Veterinary Practitioners Acts and as per most of the State , Veterinary Practitioners Acts and the Indian Veterinary Council Act, only veterinary graduates are eligible for registration. However, as per the Maharashtra Veterinary Practitioners Act, 1971, a person can be registered even though he may not be possessing qualifications entitling him fo have his name entered in the register.
- (e) As provisions in the Indian Veterinary Council Act,. 1984 have been made on the basis of provisions available in mostpf the State Veterinary Practitioners Acts, and the Indian Medical Council Act, there is no proposal to amend the Indian Veterinary Council Act, 1984.

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE COOPERATION IN MINISTRY OF AGRICULTURE (SHRI SHYAM LAL YADAV); (a) Veterinary field assistants, stock assistants etc. look after the work of veterinary first aid centres/stockmen centres located in rural areas under the administrative and technical control of veterniary assistant surgeons of nearby veterinary hospitals or dispensaries.

- (b) The Indian Veterinary Council Act, 1984 fully safeguards the duties and responsibilities of veterinary field assistants/stocks assistants etc. as such personnel can render Minor Veterinary Services under the supervision and direction of registered veterinary practitioners.
  - (c) Does not arise.

## **Eviction of Hindi News Ageneies**

- (a) whether it is a fact that two defunct Hindi news agencies are occupying prime accommodation in New Delhi without giving any rent to Government:
- (b) whether it is also -a fact that-one of these agencies has allowed some business to be opened -'n the premises near Connaught Place;
- (c) it so, what are the reasons for permitting continued misuse of the said premises: and

(d) whether Government propose to initiate eviction proceedings against the said agencies?

THE MINTSTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) Yes, Sir. The two Hindi news agencieg are Hindustan Samachar Co-operative Ltd. and Samachar Bharti which are in occupation of bungalow No. 2-D, 4-D, 6-D and 8-D, Connaught Lane and bungalow No. 13 Ferozeshah Road respectively. Both the agencies are defaulting in payment of rent for which appropriate action under the .rules is in progress,

- (b) and (c) It has just come to the notice th Ht in the open space adjoining bungalow No. 2-D and 4-D, Connaught Lane a Dhabha  $i_s$  being run unauthorisedly.
- (d) Appropriate action is being taken under the rules.

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) The DDA has informed that some representations have been received against the promotion of Mates to Assistant Superviser in DDA. The seniority list of Mates has, however, not yet been finalised. The seniority of the cadres are being prepared/published taking into consideration, all employees of the Authority working in the various Branches | Deptts, and not specifically of the Western Division.

- (b) The representations received in this regard have been considered by the DDA and some of them have been decided.
- (c) The remaining representations are heing examined by the DDA and are expected to be decided shortly.
