According to this limited study, 1.6% children in rural areas and 1.23% in urban areas in group 5-14 years were having signs of delayed development from mild to profound degree.

The CWC could not undertake the construction so far since suitable land for this purpose not allotted by RIC to CWC. reason for non-allotment of land by RIC was that it had been given the land by the West Bengal Government for rehabilitation of various industries only.

(c) The CWC has been asked to send particulars of the land considered suitable for construction of a godown in RIC Complex to enable the Central Government to take up 'he matter of allotment of land to CWC with the West Bengal Government,
