REPORTED REMARKS OF THE HOME MINISTER, SHRI. BUTA SINGH, AGAINST THE CHIEF MINISTER OF ANDHRA PRADESH.

PARVATHANENI UPENDRA (Andhra Pradesh).. Mada_m Deputy Chairman, I think you for allowing m_e to make this special mention which is very important and serious and also unpleasant for me. I would like to refer to the utterances of the Union Home Minis'er, Mr. Buta Singh, during his recent visit to Andhra Pradesh.

THE MINISTER OF HOME AFFAIRS (SHRI BUTA SINGH): It is based on the press report.

SHRI PARVATHANENI UPENDRA: Yes, based on the press report. (Interruptions).

THE DEPUTY CHAIRMAN:: Order, please.

SHRI BUTA SINGH: I just want to submit this. Let us be fair. These are press reports till I speak.

SHRI PARVATHANENI UPENDRA: I said, "based on press reports." I also received reports over telephone freim other sources,

AN HON. MEMBER: Unreliable sources. (Interruptions)

SHRI PARVATHANENI UPENDRA: Madam will you please contain them?

THE DEPUTY CHAIRMAN; I request all the hon. Members to give a peaceful hearing to what the other hon. Members have to say. You will have a chance to reply. Please keep the atmosphere peaceful in the House.

SHRI PARVATHANENI UPENDRA: Madam Deputy Chairman, I have said the matter is very serious because it affects the Centre-State relations in

a very adverse manner. (Interrup tions) And it is _____ (Interruptions).

THE DEPUTY CHAIRMAN; Order, please. I request all the Members not to create any disturbance.

SHRI PARVATHANENI UPENDRA: It is very unpleasant for me because personally, Mr. Buta Singh and I are known to each other 'Or the last fourteen years an' we have been very good friends. Whatever I say today has nothing emanating from malice or ill-will towards him. I respect him still. But I take serious exception to his utterances, as reported in newspapers. (*Interruptions*).

SHRI B. L. PANWAR (Rajasthan): I have got a Point of order to make.

SHRI PARVATHANENI UPENDRA: Madam, these remarks of the hon. Home Minister were made during his election campaign in Guntur District where a by-election fo the chairmanship of the zilla parishad is taking place today. The regular elections were over earlier. Due to the death of the Congress candidate who was elected there, wi'h a 40, CQG majority, in the last elections, this by-election is taking place today. I can understand the anxiety of the Congress Party to retain this seat. (Interruption)

THE DEPUTY CHAIRMAN: Please try to he very brief.

SHRI PARVATHANENI UPENDRA: I cannot be brief. I have to make my point. You cannot contain them.

THE DEPUTY CHAIRMAN; I have requested everybody to listen quietly. Please bear in mind that this is not a full-fledged discussion. This is a Special Mention.

SHRI PARVATHANENI UPENDRA: If they disturb me, how can I finish?

THE DEPUTY CHAIRMAN; I have requested them also. It is not only you that I am telling this. I have told

everybody. This is something special about the Special Mention.

SHRI PARVATHANENI UPENDRA: Thank you, Madam.

SHRI LAL K. ADVANI (Madhya Pradesh): Not even during the Budget Session, do we have five Ministers sitting in the House. (*Interruptions*)

SHRI PARVATHANENI UPENDRA: Madam, if they keep on this ding-dong battle, there will be no end. Please contain them. They disturb me every minute.

THE DEPUTY CHAIRMAN: Will you please keep quiet?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES, AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM): If you say that five Ministers are here, then 12. Ministers are there, at Guntur. (Interruptions)

And I also challenge him to show one instance where my party or my leader has preached separatism in any speeches or in any

(Interruptions) He, the Home Minister, cited in support of this" the campaigning by Mr. Rama Rao in the recent Nagaland and Haryana elections, " as proof for this. He says. "Rama Rao campaigned for the Nagas who want to break away from India"-all Nagas, mind you. Naga National Democratic Party is a recognised recognised by the Election party, Commission. It has not been banned and you cannot call them separatists. 'Rama Rao compaigned for the Nagas. In Haryana also he advocated separatism and casteist feelings. " I' was with the Chief Minister when he campaigned in Haryana. In every speech which he made in Hindi, the preached nationalism and unity of this country. If the Home Minister can show one speech in Haryana where we preached casteism and regionalism, I am prepared to resign my membership here... (Interruption)

SHRI JAGESH DESAI(Maharashtra): On a point of order. He has described some torn sentences. There is no need to expand this subject in a Special Mention...

SHRI V. NARAYANASAMY (Pondicherry): It should be not more than three minutes.

THE DEPUTY CHAIRMAN; In the case of Special Mentions, generally, one or two Members are allowed to' associate themselves. But I have already received eight names.

SHRI SAT. YA PRAKASH MALAVIYA (Uttar Piadesh); All of them are associating themselves?

THE DEPUTY CHAIRMAN; I have eight names here. This is also not according to the tradition. (*Interrwp-tiojts*) They have been allowed by the Chairman.

SHRI PARVATHANENI UPENDRA: When we discussed this with the Chairman in the morning, he said that after I make the Special Mention, one Member from each Party will be allowed to associate himself. Associating or contradicting. The Home Minister is here and he is competeh to defend himself and reply. Why should you allow others?


SHRI DIPEN GHOSH; I agree with you.

Member has put it through what he called a point of order. There is no point of order. (Interruptions) Please listen to me. Let me make it clear. SHRI H. K. L. BHAGAT: You have unnecessarily brought the Prime Minister in it. But I want to say that we should respect everybody and by respecting everybody we should debate the matter. SHRI MURLIDHAR CHANDRAKANT BHANDARE- You are just trying to read out something. (*In. tern*

THE DEPUTY CHAIRMAN; Please conclude now.

SHRI PAWAN KUMAR BANSAL: He is raising no point of order. (*Interruptions*)

SHRI PARVATHANENI UPENDRA; This is the judgment The Chief Minister is.... (*Interruptions*) Why are you afraid of hearing the truth? (*Interruptions*)

SHRI MURLIDHAR CHANDRA KANT BHANDARE: The no

point of order, I will not permit him

SHRI PARVATHANENI UPEND-1. But I must clarify the position, t is going on record. I will take onlyhalf a minute...

SHRI PAWAN KUMAR BANSAL: He need not refer to the judgment. It cannot be a point of order. tn a point of order how can he read a judgment? He should read the Rules.

SHRI PARVATHANENI UPENDRA: Mr. Chidambaram read it. There he read it. What is wrong if I read?

SHRI P. CHIDAMBARAM: My learned friend said that this was not a judgment. I wanted to tell him what a judgment was. If he is not willing to listen to me on what a Judgment was, he can listen to the eminent advocate sitting behind him. I will hand it over to him.

SHRI PARVATHANENI UPENDRA; Madam Deputy Chairman you said you would give me half a minute. You have not given that. Unless you stop the interruptions, how can I make my point?

PROP. C. LAKSHMANNA; Madam, you please tell me whether in the name of quoting from the judgment anybody can cast aspersions on him? ... (Interruptions)...

SHRI P. CHIDAMBARAM: Are you afraid of the judgment?

PROF. C. LAKHMANNA: This is about persons in high authority. The judgment is about a particular person who lis not present. (*Interruptions*). You give your ruling. (*Interruptions*).

THE DEPUTY CHAIRMAN: You better conclude, Mr. Bhandare. (Interruptions) Well, I am giving the railing; As *the* judgement has already been delivered, and as the reference to the judgment was made he can make a reference to that. (Interruptions).

SHRI PARVATHANENI UPENDRA:

Reference to what? You quote the findings of the court, not the charges. He is reading the petitioner's charges. (*Interruptions*)

THE DEPUTY CHAIRMAN; Listen. I asked him whether it is a copy of the petition Or it is a copy of the judgment. He tells me that It is judgment. I believe him.

THE DEPUTY CHAIRMAN; Now, you don't argue. You speak. And you leave that to other Members to speak about. You please conclude. Mr. Bhandare, I request you. It is a very sentimental... (Interruptions)...

SHRI MURLIDHAR CHANDRAKANT BHANDARE: It is a court finding.

SHRI PARVATHANENI UPENDRA: 1 challenge him. He is an advocate. Let him say it is a court finding.

SHRI MURLIDHAR CHANDRAKANT BHANDARE: What happened was that this matter came up before the then hon. Finance Minister, my great friend, for whom I have the highest regard and respect, and for whose fiscal policies. I have said lots of words in this House. He sits where Mt. Salve is sitting now. (Interruptions).

SHRI PARVATHANENI UPENDRA: Is this the subject? (Interruptions) Is Mr. V. P. Singh relevant here? If you do like this, we will discuss everything from Rajiv Gandhi to... (Interruptions) We will discuss Shiv Shanker. (Interruptions) We can discuss about the Prime Minister also. We can discuss... (Interruptions).

THE MINISTER OF PLANNING, THE MINISTER OF PROGRAMME IMPLEMENTATION AND THE MINISTER OF LAW AND JUSTICE (SHRI P. SHIV SHANKER) j Don't misbehave like that. (Interruptions) Why do you start this campaign? (Interruptions).

SHRI PARVATHANENI UPENDRA: In one deal they swallowed Rs. 200 crores. (*Interruptions*) In one deal they swallowed Rs. 200 crores. They should be ashamed of talking /about corruption. The whole Government is corrupt and your Prime Minister is corrupt.

SHRI MURLIDHAR CHANDRAKANT BHANDARE-. The Chief Minister is guilty of violating the provisions of the Foreign Exchange Regulation Act....

SHRI PARVATHANENI UPENDRA: If he goes on like this, we will not allow,

THE DEPUTY CHAIRMAN; You are objecting to each and every word he is uttering. I don't understand it. Please try to be reasonable. He says 'Chief Minister' and you get "P-

SHRI PARVATHANENI UPENDRA: He was referring to Mr. V. P. Singh. Is Mr. V. P. Singh the subject here? Why did he refer to Mr. V. P. Singh?

THE DEPUTY CHAIRMAN; He is quoting him.

SHRI PARVATHANENI UPENDRA: How is he relevant here? Why did he enlarge the discussion?

THE DEPUTY CHAIRMAN: You wanted the debate and you are not allowing the debate to proceed. What is this? (Interruptions)

SHRI P. CHIDAMBARAM: Madam, those who sow the wind will have to reap the withrwind Mr. Upendra read from the newspaper attributing a certain statement to the Home (Minister, referring to the judgment of the Andhra Pradesh High Court.

SHRI PARVATHANENI UPENDRA: I object to these references. I did not quote from the judgment. *I* said that the Home Minister should not have referred to the judgment.

SHRI P. CHIDAMBARAM: Mr. Upendra referred to a newspaper report attributing certain statements to the Home Minister. Kindly listen, Upendra Ji.

SHRI PARVATHANENI UPENDRA: He is quoting from the judgement.

SHRI PARVATHANENI UPENDRA: What did I say?

SHRI Y. CHIDAMBARAM: Mr. Upendra, quoting the Home Minister said: 'I ani not saying this. The Andhra Pradesh High Court has said all this, the Minister said. 'He said this. Now we are entitled to say that when the Home Minister said that the Andhra Pradesh High Court has said this, we are entitled to say what the Andhra Pradesh High Court has said. You have already given a ruling and we can quote from the judgment.

SHRI PARVATHANENI UPENDRA: The matter is sub-judice and he should not have referred to it.

SHRI P. CHIDAMBARAM: Having received the judgment, paving suffered the judgement, why are they afraid to see the words of the judgement?

SHRI VIRENDRA VERMA: Madam, he is quoting the allegations, narrating the allegations. He should read only the operative part,

SHRI MURLIDHAR CHANDRAKANT BHANDARE: I will read (he whole judgment.

SHRI PARVATHANENI UPENDRA: What is it that he is reading? You cannot allow such things.

THE DEPUTY CHAIRMAN: Have you finished. Mr. Bhandare? Mr. Dipen Ghosh.

SHRI MURLIDHAR CHANDRAKANT BHANDARE: I was listening to him.

THE DEPUTY CHAIRMAN: Since when you stared listening to him instead of listening to the Chair? Please conclude now.

SHRI PARVATHANENI UPENDRA; You read the operative part. You read the court finding.

SHRI MURLIDHAR CHANDRAKANT BHANDARE; I am *not* trying to read out of context. I must give the context. (*Interruptions*) TheCheif Minister was guilty of violating the provisions of the Foreign Exchange Regulations Act.... (*Interruptions*,) There was corruptoin in the purchase of land. The land was bought for HUDA... (Interruptions).

SHRI VIRENDRA VERMA: He is reading the petition. (*Interruptions*)

SHRI LAL K. ADVANI: iM'adam Deputy Chairman, I request Mr. Bhandare to yield for a moment. Thank you, Mr. Bhandare. Madam, I was listening to Bhandareji And I also felt that what he was saying, if they are the Court's findings, it is really serious, it is a serious indictment. (Interruptions) Please bear with me. (Interruptions) Madam, when I got a copy of the judgement. I felt I ought to read the whole thing. I find that after all these portions referred to by Bhandareji have been stated, after that, the Court says: "While we have set out in some details the events referred to by the Petitioner as justifying the imposition of the President's Rule it is not for us to express any opinion on the same. SHRI PARVATHANENI UPENDRA; They are all irrelevant.

SHRI P. CHIDAMBARAM. I would make one plea. We will settle the entire controversy if you will kindly allow the hon. Member to read the whole judgement. (*Interruptions*).

SHRI PARVATHANENI UPENDRA: Is it the subject matter? You give a separate notice for that.

SHRI P. CHIDAMBARAM: Madam, what objection can anyone have for the whole judgement being read? What objection can anyone have, any thinking person have to the reading of the whole judgement starting from first para to the last?

SHRI PARVATHANENI UPENDRA: Why? What is the provocation for that? (Tntemiptions).

SHRI MURLIDHAR CHANDRA KANT BHANDARE: There was corruption in the purchase of land _____ (Interruptions).

. SHRI PARVATHANENI UPENDRA; Madam, are you allowing all those things? You can not allow all these things. (Interruptions).

SHRI M. S. GURUPADASWAMY: What Mr. Bhandare is reading is a narration. (*Interruptions*) Please listen.

SHRI PAWAN KUMAR BANSAL: Madam, this is what the judges Say we take it that the questions put to us by the learned counsel for the petitioner are rather addressed to the Chief Minister himself than to us. Even accepting that the healthy democratic traditions demand the resignation of the Chief Minister not *only* when he forfeits the confidence of the majority of the members of the Legislative Assembly but also on his own accord when it as shown that he is guilty of moral tuvpitude and was therefore unworthy of hollding the exalted office the call for action has to come from within, It is not a matter of compulsion from outside. (*Interruptions*)

SHRI VIRENDRA VERMA; Madam he is reading the complaint. (Inter. *ruptions*).

SHRI SATYA PRAKASH MALAVIYA: This is not the operative part. *[Interruptions]*

THE DEPUTY CHAIRMAN: You read the operative part.

SHRI MURLIDHAR CHANDRAKANT BHANDARE; I will repeat ten times before I conclude my speech. I know what I have to say. We have the freedom of expression. One hears many things which the other person does not like.

SHRI PARVATHANENI UPENDRA: Do not talk about freedom of speech. We know what you have done to the "Indian Express". Don't talk about freedom of expression.

SHRI MULIDHAR CHANDRAKANT BHANDARE: They want freedom of expression, they want freedom from laws, they can be self-confessed tax dodgers and they want to know the meaning of freedom of expression.

PROF. C. LAKSHMANNA: There cannot be any freedom of expression in their regime. Therefore, let him confute to the operative part. (Interruptions)

SHRI V. GOPALSAMY: Bofors, Bo-fors.

SHRI MURLIDHAR CHANDRAKANT BHANDARE; Now a single interruption from Mr. Gopalsamy and I will be back to the allegations.

that healthy democratic traditions demand the resignation of the Chief Minister not only when he forfeits the confidence of the majority of the members of the Legislative Assembly but also on his own accord when it is shown that he is guilty of holding the exalted office, when it is shown that he is guilty of moral turpitude.

SHRI PARVATHANENI UPENDRA: Who said that?

SHRI MURLIDHAR CHANDRAKANT BHANDARE: The Judge.

SHRI PARVATHANENI UPENDRA: No, no, it is a wrong quotation. (*Interruptions*)

SHRI MURLIDHAR CHANDRAKANT BHANDARE: From there he comes here. He has *gheraod* me from all sides. Is it permisible?

This is the judgement of the Court. This is the operative part.

SHRI RAM AWADHESH SINGH: You please examine it and if what he has said is false, you move a privilege motion against him. It is a question of privilege. He is misquoting. (Interruptions)

SHRI MURLIDHAR CHANDRAKANT BHANDARE: You move a privilege motion against me. (*Interruptions*). It is not a matter of compulsion from outside. (*Interruptions*) They do not like to hear one word of this judgement. What can 1 do? They have invited it

SHRI PARVATHANENI UPENDRA: He is coming to the operative part. Come to the operative part. I know' the operative part.

SHRI MURLIDHAR CHANDRAKANT BHANDARE; On the first part, this is the operative part.

SHRI PARVATHANENI UPENDRA: Read fully. I have got a copy.

SHRI MURASOLI MARAN (Tamil "Nadu): On a point of order.

THE DEPUTY CHAIRMAN: No point of order.

SHRI MURLIDHAR CHANDRAKANT BHANDARE: It is a part of the judgment.

SHRI MURASOLI MARAN: This House has got a healthy tradition. Mr. Bhandare its not an ordinary Member; he is a senior Advocate. He should not read something to mislead the House. He is misleading the House. (*Interruptions*)

SHRI P. CHIDAMBARAM: It is an amazing charge. I have already placed a copy of the judgement on the Table of the House. He can verify it. (*Interruptions*) Of course, I placed it on the Table of the House. You allowed me to place it. (*Interruptions*).

SHRI MURASOLI MARAN: If he is allowed to read it, he will be guilty of misleading the House, and you will be guilty of allowing it.

SHRI MULIDHAR CHANDRAKANT BHANDARE; Now let me conclude. (Interruptions)

SHRI V. GOPALSAMY: Madam I want your ruling. The Ministsr of State of Home Affairs has said hat he has placed it on the Table of the House. He cannot place it on the Table. I want a ruling from the Chair. This is 3 yery serious matter.

PROF. C. LAKSHMANNA: Under what rule he has placed it on the Table of the House? Have you accepted it?

SHRI V. GOPALSAMY: We want a ruling on this.

SHRI ATAL BIHARI VAJPAYEE (Madhya Pradesh): Have you allowed Mr. Chidambaram to lay the copy of the judgement on the Table?

SHRI PARVATHANENI UPENDRA: He cannot place it. (*Interruptions*) He is misleading the House. Under what rule have you permitted him to place it?

THE DEPUTY CHAIRMAN; There is a procedure to lay the papers on the Table of the House. According to present procedure, he has not laid i; on the Table.

PROF. C. LAKSHMANNA; They why did he say that? He is the Home Minister. He should know that. (In *termptions*]

THE DEPUTY CHAIRMAN: I am no; allowing anybody to interrupt now. Mr. Bhandare is concluding.

SHRI CHATURANAN MISHRA: Why are you allowing a quotation from that?

THE DEPUTY CHAIRMAN; That is the operative part.

PROF. C. LAKSHMANNA: It is not the operative part. That is our argument.

SHRI M. S. GURUPADASWAMY: I will give you the operative part. May I give you the operative part?

SHRI MULIDHAR CHANDRAKANT BHANDARE: No, I will read the operative part.

SHRI M. S. GURUPADASWAMY: With your permission, may I give you the operative part?

SHRI MULIDHAR CHANDRAKANT BHANDARE; I will not take it from you.

THE DEPUTY CHAIRMAN: Wait, You read what according to you is the operative part. And then Mr. Gurupa daswamy will read which according to him is the operative part. And the matter will rest there. You allow him to complete now. Nobody is listening to the Chair. What is this? Please sit down every body. Mr. Bhandare, now please conclude.

SHRI MULIDHAR CHANDRAKANT BHANDARE: Let me quote:

"The Chief Minister is accountable to the electorate who holds a watching brief to prevent mis-performstnce and

misrule by their elected represent ivcs. It is true the moral and ethical standards might differ from person to person. What might shock the conscience of one person might not cause even a stir in the mind of another. It is for the Chief Minister... *

SHRI PARVATHANENI UPENDRA: That is why we have appointed a Commission, unlike Rajiv Gandhi who is shielding..

SHRI MULIDHAR CHANDRAKANT BHANDARE: He has appointed a Parliamentary Committee. (*Interruptions*) Don't tell me that. You are guilty of dereliction of duty.

SHRI PARVATHANENI UPENDRA: That applies to your leader.

SHRI MULIDHAR CHANDRA-KANT'BHANDARE: "It is for the Chief Minister himself to make up his mind in regard to the path he should follow in the face of these allegations. No gratuitous advice, much less any specific direction, from this Court is necessary."

SHRI PARVATHANENI UPENDRA: And you stopped the work of the Commission by going to the court.

SHRI MULIDHAR CHANDRAKANT BHANDARE: He refers to the Commission of Inquiry. The other day I read in a newspaper that that Commission of Inquiry is dead because he appointed a fresh Commission... (Interruptions)... He was his legal adviser.

SHRI PARVATHANENI UPENDRA: That is wrong... (*Interruptions*)...

PROF. C. LAKSHMANNA; That is unfounded malicious.

SHRI PARVATHANENI UPENDRA: I challenge you, Mr. Bhandare; Do you stand by that statement that he worked as his lawyer?

SHRI MULIDHAR CHANDRAKANT BHANDARE: I know that... [(Interruptions)...

Madam, I will end by saying this: We are living in a democracy. We have a fierce debate. We go and say whatever we like about ourselves and whatever we like about others. It is a matter of the deepest regret to me that what was merely an election campaign should have been brought into this House. And if the matter has recoiled and if they ar© feeling that they are mauled by this debate, I have only to say that they have only to blame themselves for the very unenvious position in which they have placed themselves.

There is no doubt in my mind since this question raises an important, aspect of State-Centre relationship that a monolithic national party like the Congress is the only alternative before the people.

SHRI ATAL BIHARI VAJPAYEE: Look at the monolith!

SHRT DIPEN GHOSH: Madam Deputy Chairman, I am glad and I must particularly thank my learned colleague, Mr. M. C. Bhandare, that he has relied more om a court judgment than on any other paper — not the newspaper. SHRI P. SHIV SHANKAR; Madam, I am sorry, may I have a say?

SHRI DIPEN GHOSH: I did not mention his name, Madam.

SHRI DIPEN GHOSH: I have not had my say, Madam, Unless and until I have had my say, how can he make his statement?

SHRI DIPEN GHOSH: I am not going to yield.

SHRI DIPEN GHOSH: If I refer to you or your statement then you will have the right to explain but not by stopping me. After I complete,.. (*Interrup*-

AN HON. MEMBER: He says that he is on a point of order.

THE DEPUTY CHAIRMAN; Sit down first. You please finish with your point of order Mr. Shiv Shanker.

SHRI P. SHIV SHANKER: I was trying to submit that I was speaking on the accountability of the Legislature, Executive and the. Judiciary under the Constitution and I developed my theme to say that because the people of India are sovereign, therefore, all these three institutions have got to be accountable to the people of India. Then the question I raised was that because the majority of the people of India are the poor masses, how far the three institutions have accounted themselves to those persons. That was the theme which I was developing. And having developed it, then I came to judiciary. I started with the role of the Supreme Court right before Independence and after Independent If my speech is read thoroughly as as

whole in the *context in which* spoke, I was referring to the role of the Supreme Court 20 years after that was se* up from 1950. I said — the Zamindari abolition, regulations, how it met the fate and what actually happened, how the people were meted out jusficc. It is those things which I referred to. I did not refer to the matters at this stage. In fact, I am proud that the Supreme Court; i least from 1980 has taken up the cause of the common man. (Interruptions)

THE DEPUTY CHAIRMAN: Shri Dipen Ghosh will continue.

SHRI DIPEN GHOSH: Madam Deputy Chairman, I have not seen the full text of Mr. Shiv Shanker's speech, but at least by making a submission he has admitted that prior to 1980 the Supreme Court was not performing... (Interruptions).

AN HON. MEMBER: Don't misinterpret

SHRI DIPEN GHOSH: Because just now be has used the sentence at least since 1980, the Supreme Court has been taking up the cause of masses.

SHRI P. SHIV SHANKER: Yes, I stand by that.

SHRI DIPEN GHOSH: So, it is concluded that a prior to 1980 the Supreme Court could be accused of not taking up the cause of the masses. Is it so?

SHRI P. SHIV SHANKER; Shall *I* say that the legal aid was abolished when the Janata Party Government was in power?

SHRI DIPEN GHOSH: Janata party was in power for two and a half years. Before 1980, from 1947 to 1980, for only two and a half years Janata Party was in power. You used in your expression in English 'since 1980'. Since 1980, that means....

THE DEPUTY CHAIRMAN: I would like to remind the Members to restrict their speeches to the subject.

SHRI DIPEN GHOSH: Madam, I appreciate Mr. Bhandare's increasing reliance on the High Court judgment because in the meantime, the right of the court. status or the role of *thi* court has been questioned by the Members belonging to the Treasury Benches. That is one aspect.

THE DEPUTY CHAIRMAN: Put your point now.

SHRI DIPEN GHOSH: This is the newspaper report. Until and unless our hon. SHRI DIPEN GHOSH: Madam, you can recall how the Prime Minister had acted on the eve of West Bengal poll — how he had gone from length to breadth In West Bengal accusing the Chief Minister __ "ageing Chief Minister" and other Ministers in his speeches.

SHRI P. SHIV SHANKER; Madam, my submission is, are Tripura and West Bengal within the purview of what was said by Mr. Upendra? (*Interruptions*). No Madam, you must listen.

THE DEPUTY CHAIRMAN: Mr. Dipen Ghosh will continue. Please do not go outside the purview.

SHRI LAL K. ADVANI: Madam, tht purview is Centre-State relations. That is the basic issue.

SHRI DIPEN GHOSH: I give a right to Mr. Buta Singh as leader of the Congress (I) to take part in electioneering whether it is in Guntur, Nagaland, Haryana or anywhere else. But the question is, there are certain remarks having been made by Mr. Buta Singh as Home Minister that make me concerned. good. (Interruption). It good. Mr. Bhardwaj, please wait until I frame my question. He will reply. You please wait. You are the Law Minister. Please do not create lawlessness here. (Interruptions) Madam Deputy Chairman the other day I had the opportunity of meeting the Home Minister, Buta Singh, in his chamber, about certain reports on the Haryana by-election. Certain reports came to us and we wanted to discuss with the Home Minister before the election date. I think it was two days before the election date. Mr. Buta Singh had informed me-I do not know whether Mr. Buta Singh will agree or disagree with me on that statement now - "First of all, holding of election pertains to the Election Commission. Maintenance of law and order connection with the election pertains Government. I. as the Home State Minister of India, do not come into the picture anywhere. " It was his reply. (Interruptions)

SHRI DIPEN GHOSH: Exactly.

SHRI BUTA SINGH: Let me complete now. Also, as I have said, these reports, which Mr. Upendra has read and Mr. Dipen Ghosh is reading, are taken as gospel truth by them without verifi-catioui. They are basing every argument of theirs on these. And he is trying to prove the case of another State. In connection with the elections, I will go there when the elections take place in Tripura alsoi (Interruptions)

SHRI DIPEN GHOSH: More you will be coming to our State and more your party will be defeated. That is why I hold out my permanent invitation to all of you. Madam Deputy Chairman, the Home Minister himself has admitted that if the State Government wants, then the Central Government comes into the picture. That is why I consider it wrong. Had he gone there as a Congress-I leader to take part in electioneering, for the purpose of making the Congress-I candidate there win, then it was all right, I would not have objected to it. But the question is, as the Home Minister he has stated. So, I think this is wrong.

The second point is-Mr. Bhandare had also tried to dwell on it-about the parochial attack and all that. It is true that there are parties, there are groups, who indulge in separatism, divisive activities and fundamentalist activities and thereby endanger the unity and solidarity of our country. It is true. There are such groups dparties. Which party, group, I am not going to say. There are parties and groups... (Inwho directly indulge in terruptions) separatism, divisive activities fundamentalist activities. There are parties and groups who encourage and abet these. And the foremost

[Shri Dipen Ghosh] party, which is indulging in encouraging those parties and groups, indulging in activities of separatism, communalism and fundamentalism, is Congress-I of which Mr. Buta Singh is the Home Minister. He has taken objection for Mr. NTR going to Nagaland and Haryana. And while going in Nagaland, even Mr. Bhandare said, he encouraged Nagas, etc. The other day I heard even underground Nagas are going to be called to Delhi for giving a red carpet ovation. Who is encouraging separatism? We know who had encouraged Ghei-shing. We know who had been encouraging TNV? TUJ is the legalised signboard of TNV. They are allied with TUJ. Before complaining against others, let Mr. Buta Singh search his own heait.

Finally, even in regard to corruption why are they making so much noise? There are more skeletons in their cupboards and those skeletons are stinking and that is why they want to try to cover up their cwn misdeeds and that is why they are picking up all these court cases. So, in the background of this debate, in the background of Sarkaria Commission Report which has since been submitted to the Government, I say there should be a full-fledged debate on the strained Centre-State relations.

SHRI BUTA SINGH: Madam, have you observed how he has carefully avoided defending Mr. Rama Rao?

SHRI A. G. KULKARNI: Madam, I am limiting myself to the news item in the "Newstime" from Hyderabad. I am not such a learned person to go into the intellectual judgments. But I have enough common sense to understand what they want to say. I have listened to Mr. Upendra. At the outset I object why my friend, Mr. Upendra, has taken the view that Mr. Buta Singh has gone out of the way, that there is the Centre-State relations question, etc. I think many of my colleagues in the Opposition parties are unnecessarily taking a very serious, an uncalled

for, view of a very small matter. Madam, Mr. Buta Singh—it is known and perhaps Mr. Upendra will bear me out—went there for the Guntur elections for pleading for the Congress (I) candidate, for getting votes for the Congress (I) member. SHRI A. G. KULKARNI: Do you mean to say that the ADMK Chief Minister cannot go to any other place?

SHRI V. GOPALSAMY: Law and order is a State subject. What business have you got there?

SHRI A. G. KULKARNI: Please let me make my point. Now, he has mentioned about some crores of rupees, etc. How many crores', God alone knows. But it was in the reply in the Rajya Sabha that there were some dues, about Rs. 95 lakhs from Mr. N. T. Rama Rao. I do not think so. But I do not know also whether it is correct or whether it is incorrect or whether it is in dispute. But as a senior artiste, I do not say as. the Chief Minister, he owes much to the Government because senior artistes always owe much to the Government... (Interruptions)...

SHRI PARVATHANENI UPENDRA: It is only Rs. 4. 9 lakhs.

SHRI A. G. KULKARNI: Madam, the honourable intellectual leader of the Telugu Desam Party is saying..

SHRI PARVATHANENI UPENDRA; I only corrected it. It is only Rs. 4. 9 lakhs.

SHRI A. G. KULKARNI: Rs. 4. 5 crores?

SHRI PARVATHANENI UPENDRA; I corrected it; it is only Rs. 4. 9 lakhs.

SHRI A. G. KULKARNI: But the entire amount was Rs. 95 lakhs.

SHRI PARVATHANENI UPENDRA: Maybe in the case of Mr. Amitabh Bachchan.

SHRI A. G. KULKARNI: MKdam, I want a clarification from him. Has he not received, between November 22 and 28, various petitions from the

people of Guntur taluk regarding possible threat of booth-capturing and not permitting the weaker sections to vote? My friend from the other side, instead of bringing the Centre-State relations, etc. (Interruptions) My frend Mr. Bhandare has already explained, and I do not, want to create another hornet's nest and thus create more problems. But I have already stated in my first intervention that the court has given advice... (Interruptions) A morally upgraded man like NTR should ask his conscience...

SHRI PARVATHANENI UPENDRA: You read the judgment.

SHRI A. G. KULKARNI; I can read it for you. (Interruptions) It is page 13 of the judgment. It is WP 12425 of 1987: that is the judgment Number. (Interruptions) Don't unnecessarily provoke me. This is of second November... (Interruptions).

PROF. C. LAKSHMANNA: What is this? (Interruptions)

THE DEPUTY CHAIRMAN: Mr. Upendra asked him to read the judgment.

PROF. C LAKSHMANNA: Mr. Upendra is not deciding. Mr. Upendra cannot decide. Are you overruling your ruling? (Interruptions)¹

THE DEPUTY CHAIRMAN: No-body can threaten me.

PROF. C. LAKSHMANNA: 1 am asking you: Are you over-ruling your own... (Interruptions)

SHRI P. CHIDAMBARAM: Mr. Upendra savs that the court has not said this. Is it not the right of the Member tosay that the court has said it? (Interruptions)

SHRI A. G. KULKARNI: Healthy democratic traditions demand the resignation of the Chief Minister, not only when he forfeits the confidence of the majority of the Members of the Legislative Assembly but also of his own accord, when it is shown: that he is guilty of moral turpitude

[Shri A. G. Kulkarni] and, therefore, unworthy of holding a_n exalted office. The call for action has to come from with. And I appeal ... (*Interruptions*) It is not a matter of compulsion. (*Interruptions*)

SHRI PARVATHANENI UPENDRA: Read the whole thing.

SHRI A. G. KULKARNI: That you read.

PROF. C. LAKSHMANNA: What is this? (Interruptions)

SHRI A. G. KULKARNI; This country has a heritage, culture, of thousands of years, and...

SHRI PARVATHANENI UPENDRA: You started it?

SHRI A. G. KULKARNI; I am doubtful of your party. (Interruptions).

SHRI B. SATYANARAYAN RED-RY (Andhra Pradesh): You are changing from this side to that side: Is that your culture?

SHRI PARVATHANENI UPENDRA: "What is your culture? (Inter-rutions)

SHRI N. K. P. SALVE; Agriculture! (Interruptions)

SHRI A. G. KULKARNI; Madam, I say that this country has got a culture.

SHRI PARVATHANENI UPENDRA: You have done enough. You have proved that you are a Congress (I) man.

SHRI A. G. KULKARNI; Madam, whatever these intellectuals may say. there is a common courtesy of a common man or a common woman with a little intelligence at least to listen to what the sages orthe intellectuals say. The Chief Jsice of a High Court has said it. (Interruptions)

SHRI PARVATHANENI UPEND RA:

SHRI A. G. KULKARNI: I am making my last point.

SHRI PARVATHANENI UPEND RA:

SHRI A. G. KULKARNI; If you want to say anything about him, go to the court, flic a petition in the Supreme Court and get decisions. This is the only way.

SHRI PARVATHANENI UPENDRA:....

SHRI P. CHIDAMBARAM; There are serious aspersions which Mr. Upendra has cast on him. I am sure he would like to withdraw them on second thought. (Interruptions) I am appealing to his good sense. He has made very serious allegations against him.

SHRI PARVATHANENI UPEN-DRA::...

THE DEPUTY CHAIRMAN; Any aspersions cast on the Chief Justice or the High Court Judge will not go on record.

SHRI A. G. KULKARNI: I am finishing. I want to know from the Home Minister whether it is a fact that in a Malyalam daily, dated 14th November, 1987. there is a report. (*Interruptions*)

It is in Malyalam. I have got a copy in English. I do not wanto quote or say anything. They have stated.

SHRI B. SATYANARAYAN REDDY: Who translated it?

SHRI A. G. KULKARNI: Mr. Go-palsamy has translated it. (*Interruptions*)

SHRI PARVATHANENI UPENDRA: Is it within the scope of the discussion? You have given the parameters. Ho cannot read from every document.

SHRI A. G. KULKARNI: The pa-r'moter is this judgment

SHRI BUTA SINGH; The who!« discussion ig based on press reports. He is also reading a press report.

SHRI PARVATHANENI UPEND-RA: What is this report? There ar«

hundreds of press reports. We cannot refer to hundreds of press reports. We are not discussing all the press reports. We cannot go on like that.

SHRI A. G. KULKARNI: The Chief Minister brought one Lakshmanan... (Interruptions)

Madam, the allegation is that the Chief Minister brought one Lakshmanan in Hyderabad to file a writ petition against the Chief Justic. So, in this connection I want to appeal to all the political parties—this is my last sentence--that for heaven's sake, for cheap popularity do not indulge in politicising either the judiciary or the administration. (*Interruptions*) Nobody is going to gain by it. But the moral. standards in this country will go down, for heaven's sake do not play with the fire. I only advise my friends.

SHRI M. S. GURUPADASWAMY: Deputy. Chairman, I must Madam congratulate the people of Guntur for having got the love and affection of five Central Ministers. And in Guntur the occasion was and is a local election to Zilla Parishad. It"was not a parliamentary election nor an election to the Legislature. It is an election to the ZillaParishad. I don't think to my knowledge, in the history of this country since independence, any Central Ministers went to canvas for Zilla Parishad elections. There is nothing wrong in going for canvassing. I don't object at all. I Only express my ami'sement on the whole thing that how a petty election which will not decide the fate of the State Government or the Central Government could attract the attenion of five Central Ministers.

AN HON. MEMBER; What was wrong in it?

SHRI H HANUMANTHAPPA (Karnataka): Will you yield for a minute?

SHRI M. S. GURUPADASWAMY: No, I-have no time. Madam, I do not want to try the patience of the House. If anybody can remove Mr. Buti Sineh from the speech, from

the body of the speech. what impression does this convey to anybody, to any person? you go through the speech, the language used the expressions used, they do not convey that the language and those expressions were from a cultured person. I appeal to not like your sense of decency. That is all. More than that I cannot do anything. I appeal to the sense of decency of all Members of the House. But I give three gems read have been picked upwhich with those gems is the photo of my friend also. One precious gem is: "Shri N- T Rama Rao has stolen crores of rupees from income-tax. He has acquires crores of rupees worth riroperty. I am not. -ayini thus. The Andhra Pradesh High Court has said all this. ' Another gem is: "I. as Home Minister of India, had come to personally monitor the situation in Guntur. " He had personally gone to monitor. That is the word. "Anybody who tampers with the election process will not be lit off. The Central Government will take strict action. " Under what rules I do not know. The third gem is: "The Chief Minister can't stop even women being raped under his very nose in the MLAs hostel. Tha Prime Minister had to go all the way from Delhi to save them. —from rape. "The Prime Minister had to go from Delhi to Hyderabad to save women from rap?. There are other gems also in the speech

Please forget your party. I want to forget my party. I am not quoting the law here. Is it all proper? (Interruptions'). Please listen. Please give me this enefit. Will you call this speech a proper decent civilised speech? Can you?

HON. MEMBER. Yes.

SHRI M. S GURUPADASWAMY: I am getting the echo of culture. That is all I *can* say. I am only saying that this speech as it is, is a speech of garbage. It has the language of a chaprasi.

SHRI MURASOLI MARAN: Sir, I object to i. Chaprasi uses very civilised language. (Interruptions)

SHRI BUTA SINGH; *i* respect chaprasi qually as I respect the Hon. Member.

SHRI KAMALENDU BHATTACHARJEE; You are saying Mr. Buta Singh has lost his balance. The fact is that you have lost your balance

SHRI M. S GURUPADASWAMY: To keep the temper of the House I withdraw that expression. If you go through the speech, you will get an inevitable impression that Mr. Buta Singh employed the language deliberately to intimidate... (Interruption) He will not intimidate you, I am sure, Mrs. Natarajan. Mr. Buta Singh employe;] the language deliberately to intimidate overawe and bludgeon the State Government by using a small stick like "this This is only a Zilla Parishad election. It is too small. If he had taken a bigger issue, I would have been happy. After all, we fight political battles. There is nothing wrong in that. But the way, he has gone about, warning the local officials district officials is not proper. It is not your concern. You have gone there to campaign. Campaign and come back. No objection. Why should you call the officials and warn them, threaten them? For what?

DR. H. P. SHARMA (Rajasthan). Against tampering of ballot boxes. (Interruptions).

SHRI M. S. GURUPADASWAMY. The law is there. You are not a substitute for law. (Interruptions).

SHRI DIPEN GHOSH: What did yeu do in 1970 (Inten-uprions) Where were you at that time, at the time of West Bengal and Bihar elections? (*Interruptions*)

SHRI M. S. GURUPADASWAMY. Tht; courts are there. It is not your concern. It is not your responsibility at all. You cannot call them, warn them, threaten them, intimidate them create fear in their minds. No. It is not your jurisdiction. Mind you. You may be the Home Minister. But the Home Minister has certain restrictions. You cannot function this way. This is not the way. If you had not done this, I would have been happy.

Madam, my friends were reading excerpts from the judgement. My friend, Mr. Bhandare, was quoting from narration. In a judgement, there are various parts. My friend, Mr. Chidambaram, knows much more than me. He is an active lawyer. There is a narration part and there a're other parts. The most important part is the operative part. There were two writ petition. I will read out the operative part only. In the firsi writ petition the operative part is like this:

"We have no doubt in our mind that whateve'r be the merits of the allegations made, if and when found appropriate, the power to termlna te the tenure of office of the Chief Minister being vested solely in the Governor under article 164(1) of the Constitution, no writ of quo warranto as prayed for would" is-! sue from this court. In that view, the writ petition is dismissed, without any order as to costs."

In the second writ petition, the ope rative part is

SHRI KAMALENDU BHATTA-CHARJEE: You are confused.

SHHI M. S. GURUPADASWAMY: It is you who is confused. Why do you confuse me?

It is on page 29 which says.

"While we refuse to give anv Central Govern direction to the ment in the terms played for by the petitioner, we have no doubt that the writ petition filed by the peti tioner as well as the details set out in the judgement will receive the consideration of the Central Gov ernment and an appropriate sion will be taken_

SHRI P. CHIDAMBARAM; Mar* the words 'as well as the details...'

SHRI M. S. GURUPADASWAMY. The verdict is: 'The writ petition is accordingly dismissed with the aforesaid observations'.

SHRI P. CHIDAMBARAM: Again mark the words 'wth the aforesaid observations'.

SHRI M. S. GURUPADASWAMR: The Judgement finally says 'There shall be no order as to costs' (*Interruption*) I am only reading the opera tive part. What is your difficulty?

SHRDI P. CHIDAMBARAM: If you will yield for a minute.

SHRI M. S. GURUPADASWAMY: I am not yielding.

SHRI P. CHIDAMBARAM: You read the details.

SHRI M. S. GURUPADASWAMY: | I am not yielding (Interruptions)

THE DEPUTY CHAIRMAN; Please conclude now.

SHRI M. S. GURUPADASWAMY: You are a learned lawyer. You understand.

SHRI P. CHIDAMBARAM: I appeal to you to read the details.

SHRI M. S. GURUPADASWAMY:

I do not want to go into the details. I am only reading the oeprative part. Only operative part. Madam, I am not holding brief for Shri N. T. Rama Rao. Let me say finally, if he has committed any wrong, any improper action, if he is involved in any moral offence, then there is law for that Already he has appointed a Commission to go into. -(Interruptions). Your difficulty is, it is a very comprehensive investigation wherein even Congressmen will be brought in. Your people have been the rulers of Andhra Pradesh since 1956. All your leaders wil be brought in. That is your fear.

SHR1 V. NARAYANASAMY: Including Janata Party leaders.

SHRI M. S. GURUPADASWAMY: I am not defending anybody, let me tell you. You are suffering from a sort of paranoia, a particular psychological fear which you cannot get over. Therefore, let us think of this in a proper perspective. If any wrong has been committed by my friend, Mr. Buta Singh, if the speech, as it is printed, is true, the minimum that I expect is that he must express his regret. And if he has any evidence to prove that he has not made the speech, he must tell us. Of course, we are not holding any inquisition here. We may be at fault, we may be wrong. We are basing our charges on the basis of the printed material. It is all quoted here for authenticity. If my friend thinks that he has at all made the speech, the least I expect from him, as a civilized person, as a Membber of this House, is regret, an unqualified regert Thank you.

SHRI N. K. P. SALVE: Madam. so far as the constitutional proposition is concerned, if a Union Minister is vefering to any Minister in any State, whether he be the Minister or the Chief Minister of a ruling party or the opposition party...

SHRI DIPEN GHOSH: Tomorrow Guntur result will be out. Will the Minister be available in that case?
