Need to Check Deforestation

SHRI DHARAM CHANDER PRA-SHANT (Jammu and Kashmir): Madam, Deputy Chairman, I rise to speak on a subject which is connected with forestry which is the wealth of the country. Forests are being cut indiscriminately decreasing the wealth of the country. It pays revenue to the States but this cutting of trees affects many aspects. Forests protect wild life, they give rains, there is cool climate and many other aspects are there. There is a proverb, world forestry goes on improving but the forests in India go on decreasing, thinning.

Madam, I have met Mr. Sunderlal Bahuguna two-three times who has organised 'chipko' movement in India. He travels from one place to another on foot and covers thousands and thousands miles creating awareness among the people not to cut trees. Trees are felled with speed and who is responsible for this? The major responsibility falls on various lessees and contractors and also the State Governments and their officers because this pays revenue to the State. In my own State, in 1947, annual revenue from forests was Rs. 40 lakhs and now it has gone up to Rs. 60 crores This is the reason why forests are thinning in various States of the country. If we do not check this rapid felling of trees. India will one day be converted into a desert and the climate will also be very hot. So, I request that concrete, effective and harsh steps should be taken to stop indiscriminate felling or cutting of trees, especially to protect wild life. We see thousands and thousands of birds coming from foreign countries staying in the forests of India We will be deprived of them if forests became thinner and thinner.

Need to Ameliorate the Condition of Artisans and Craftsmen

SHRIMATI ELA RAMESH BHATT- (Nominated): Madam. I would like to draw the attention of the Government to a matter of public importance. Shrimati Anes Jung's article of 7th November, 1987, on the plight of a national awardee Padmashri, painter Gangadevi of Mithila, makes tearful reading. She is ailing with cancer today. No wonder, mere awards

like a letter of the First Lady of the country will not satisfy her when Gangadevi has not enough to wear, enough to eat, enough to buy medical care and enough to survive her old age with dignity. Gangadevi may, now, receive some either through Government or through a sympathetic philanthropist.

Special

However, the issue is, how are we going to protect our cultural heritage without protecting our craftpersons and artisans? They receive some publicity and admiration for a while when we give them awards, but soon we leave them to survive against the forces of industrialisation, market mechanism and inhuman modernism.

Madam, if this is the fate of the national awardee Padmashri Gangadevi, waat about the 30 lakh craftsmen and artisans who have not been identified and recognised? We use their products for building our national image abroad and enrich our museums. Their products are exported abroad by merchants, who Designers and mediamen do thriving business through $an_{\mathbf{d}}$ mentation publication. Export Councils and Promotion have yet to make an impact on craftsmen's working and living conditions,

Madam, Gangadevi's condition is typical of the condition of thousands of artisans and craftsmen in India. We need to *develop such programmes and policies at Central and State levels that directly improve their quality of life and ensure social security when they are ill, old and devoid of income.

The State Handicraft Boards do assist them to a certain extent by buying their products But beyond that the Boards have no relationship with the lives of the artisans and craftsmen. Madam, I urge the Government to frame a national policy on crafts persons, for whom we should ensure a fair return for their work and self-respecting conditions of work and living. Their welfare cannot be ignored any longer, as it is bound to affect their productivity, apart from their wellbeing

Their homes are their work places; so proper housing is the foremost measure. General insurance companies may be roped in to devise suitable insurance against meternity, incapacity illnes, and old age and for award winners, a monthly income scheme under the Unit Trust may be introduced. A Central fund may be created for medicare of the ailing artisans and craftsmen.

The country earns foreign exchange close to Rs. 1000 crores from handicrafts, handloom and ready-made garments. So, Madam, there is ample scope and justification for investment in providing social security and welfare schemes for artisans and craftsmen of our country. Thank YOu.
