Ke Government's failure to implement the package of Benefits for Central Government Doctors

SHRI PARVATHANENI UPENDRA: (Andhra Pradesh): Mr. Vice-Chairman, Sir, there is a lot of unrest among the Central Government doctors because of the nonimplementation of the package of benefits announced by the Government. As you are aware, the nine-day old strike was called of on the 29th July and on the 30th July, the Government announced a package of benefits. Though three months have passed, the Government has not implemented many of them. As envisaged in the package, the annual contingency allowance has not been released yet. The only thing they have done is that they have issued orders in regard to promotion of medical officers as senior medical officers. But the rest of the things are all pending.'Nonpractising allowance given is in slabs and not in percentage. The question of enhancement of retirement age to 60 years for dectors, as is already prevailing in the All-India Institute of Medical Sciences, has to be considered but nothing has been done in this regard. Again, the main demand of (hree time-bound promotions with a higher starting scale was to be referred to a Committee of Ministers but nothing has so far been done in this respect.

Lastly, the cadre review committee which is at work did not even care to take the views of the doctors' associations. This is very essential. They should also be given an opportunity. I have already brought this to the notice of the hon. Minister for Human Resource Development. I have also written to him. I hope Government will implement this package of benefits immediately so that this unrest will end and the doctors will benefit

Re; Non operational 'refuse Incineration ium power generation plant' of Municipal Corporation of Delhi in Timarpur

DR. H. P. SHARMA (Rajasthan): Mr. Vice-Chairman, Sir, through this special mention I would like to draw the attention of the House and the Ministries concerned about a 20 crore plus Timarpur refuse incinerationcum-power generation plant of the Delhi Municipal Corporation which was slated to be commissioned in March, but after eight months it is still not fully operational. The information given to me is that the plant has so far worked for only 14 days in March, 10 days in April and only 5 days in May. The plant which was supposed to go into full operation last March is still anybody's guess when it will be fully in operation. The reason given is the alleged failure of the Municipal Corporation of Delhi to provide the required garbage.

Sir, the total garbage of Delhi is about 2500 to 3000 tonnes per day. The requirement of the plant is only 300 tonnes a day and yet this inability to provde 300 lonnes out of 3000 tonnes does -lot speak very highly of the performance of the Delhi Municipal Corporation. Sir, scientifically, it is the most wholesome solution to the garbage disposal. While disposing of the garbage you also generate power through this Timarpur plant. It was supposed to generate 3.75 mw of power every day and out of this 3 mw had to go to the Wazirpur water pumping house. But the position today is that instead of providing the 3 mw power it is taking rom DESU the power worth about Rs. 20,000 a month.

The disturbing fact to me is that no less than six most important orgainsat'ops were formulatting and implementing the plant and they are, the Municipal Corporation of Delhi. Delhi Adminstration. DESU. BHEL, Planning Commission and Commission for Additional Resources of Ecnreey. When the scrutiny has to 6°

through such highly qualified ageneies and even at the end of it you say that you cannot provide 300 tonnes of gaibage, thero is something basically wrong with the planning. Mr. Vice. Chairman, Sir, it is not a new experimental plant that there might be some problems. Ther are at least 350 such plants in operation through out the world. (*Time Bell rings*). I am completing. It is happening right under the nose of the Central Government. We must attend to these problems.

I will just make one last point. This plant was supposed to be a pilot plant for four other similar plants in Bombay, Calcutta, Madras and Kanpur. If we do not make a success of this, the other four plants will not be able to start-

The plant has been implemented by taking a Denish loan of Rs. 18 crores repayable in 20 years. Once you invest such a huge amount, you have to do something about this. Four metrjpolitan cities are waiting to see the result of this plant.
