- (a) what are the special monetary benefits that are proposed by Government to induce the doctors to serve in rural areas; and
- (b) what is the expected response to these measures?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE): (a) To induce doc'ors to work in rural areas, the 8th Finance Commission, and the suggestions of the Ministry of Health & Family Welfare, has provided special funds to the States for providing the following incentives to doctors serving in rural areas and not allowed private practice:—

(i) A rural allowance equal to 25 per cent of the basic pay subject to a maximum of Rs. 250 per month for the doctors serving in Primary Health Centres; and

(ii) House rent allowance at the rate of Rs 150 per month where the doctors are not provided residential accommodation.

In addition, the Finance Commission has made special provision of Rs. 53.52 crores for construction of residential quarters for the doctors. The hilly areas have been provided 30 per cent 'mark-up' in the cost of constructions.

(b) There 1s better deployment of doctors in rural areas because of the incentives offered. As per the latest information available, 19,163 doctors are in position against the sanctioned strength of 22,049 doctors at Primary Health Centres.

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI KRISHNA SAHI): (a) No, Sir According to 1931 census Gujara; ranks 11th amongst all States Union Territories in regard to the rate of literacy.

(b) The National Policy on Education—1986 visualises eradication of illiteracy particularly in the agegroup 15—35. The Central Government has formulated a comprehensive programme in the field of adult education, known as "National Literacy Mission", with a view to providing functional literacy to 30 million persons in 15—35 age-group by 1990, and another 50 million by 1995.

Written Answers

- (c) Under Central Sector, Rs. 6.01 crores have been released to the Government of Gujarat and Rs. 6189 crores to other States from 1st January, 1986 to 31st October, 1987. The information about the actual amount spent during this period is not available.
- (d) The Annual Plan of States are finalised on yearly basis. Annual Plan for 1988-89 in respect of Gujarat is yet to be finalised
