## Night landing facilities at Indore Airport

- \*63. SHRI AJIT P.K. JOGI: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether Government are aware of the fact that several times the aeroplanes have to overfly Indore because of the fact that night landing facilities have not been provided there, inspite of adequate budget provisions;
- (b) whether it is s a fact that the work of digging for installation of VASI facilities essential for night landing was start-

ed at Indore airport some time back but there has been little progress; if so, the reasons therefor;

- (c) what steps are proposed to be taken to expedite the completion of this work;
- (d) whether the night landing facilities for other airports of Madhya Pradesh es pecially those at Raipur and Jabalpur are proposed to be provided to avoid the hardships caused by frequent over flying of aircrafts?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION AND THE MINISTER OF STATE OF THE MINISTRY OF TOURISM (SHRI JAGDISH TYTLER): (a) Yes, Sir. During October, 1987, there have been some instances of Indian Airlines flights overflying Indore as Indian Airlines had to resort to rescheduling of services due to operational reasons and the aircraft could not land at Indore owing to inadequate night landing facilities. During the last six months prior to October, 1987, there have been no instances of over-flying Indore.

- (b) and (c) The works relating to conversion of Medium Intensity Runway Lights into High Intensity Runway Lights and installation of 3-Bar Abridged Visual Approach Slope Indicator System (AVASIS) at Indore airport have been taken up. These works are in progress and are expected to be completed by the middle of 1988. Though digging for AVASIS facilities started some time back the work could not be carried out due to delay in procurement of fittings and cab-les. All efforts are being made to complete the work expeditiously.
- (d) Night Landing Facilities are already available at Bhopal. The following night landing facilities are planned for Raipiir and Khaiuraho:—

RAIPUR;— (i) High Intensity Runway Lights (HIRL).

- (ii) Precisio Approach Path Indicator—2 sets.
- (iii) Apron Flood Lights.

(iv) Simple Approach Lighting (APL-(S).

KHAJU:—(i) High Intensity Runway Lights (HIRL).

RAHO:—(ii) 3 Mar Abridged Visual Approach Slope Indication System (AVASIS) (iii) Apron Flood Lights. (iv) Obstruction Lights.

As regards Jabalpur, proximity of Ordinance Ammunition Depot to the airport does not permit operations Of aircraft under Instrument Flight Rules. Only limited operations by day are carried out under conditions of clear weather when the aircraft can navigate well clear of the danger limits. Hence, there is no plan at present to provide night landing facilities at Jabalpur airport.
