Sponge Iron Plants in Chhattisgarh were meeting their requirement from Barbil, Orissa sector as the quality of the ore was more suited to sponge iron. However, since 2003-04, prices of iron ore rose sharply and were not stable. Chhattisgarh based plants wanted to avail/increased offtake from NMDC.

In 2006-07, subsequent to meeting of State Chief Secretary with Secretary (Steel), NMDC has made available the agreed 2 million tonne of Bailadila ore to Sponge iron plants in Chhattisgarh. Following table will indicate that NMDC has made more iron ore available to State's sponge iron industry than its actual offtake.
