

(SHRI YOGENDRA MAKWANA):

(a) and (b) Due to widespread drought conditions prevailing in many States as well as floods in some Eastern States during the Kharif season, production of various crops in 1987-88 is likely to be effected. Firm estimates of Kharif production are not yet due from the States. Sowings of Rabi crops are still in progress. It is, therefore, too early to quantify the likely shortfall in production of various crops during the year 1987-88.

**Yamuna bridge at Delhi, I.S.B.T.**

Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether it is a fact that construction of Yamuna Bridge at Delhi Inter State Bus Terminal is being delayed;

(b) if so, by when it was scheduled to be completed initially and how many times the date has since been extended and by when it is likely to be completed now,

(c) what are the reasons for the delay;

(d) whether the Lt. Governor of Delhi in his letter to the Minister of Urban Development had suggested monthly monitorings on the N.B.C.C. regarding the progress made; and

(e) if so, what are the details thereof and action taken thereon?

**THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH):** (a) to (c) The project was scheduled to be completed by December, 1987. However, the target date of completion has been revised to Dec., 1988, on account of following reasons.

1. Delay in the removal of encroachments coming in the layout of the bridge and connected flyovers.

2. Shifting of Services like Sewerlines, electric cables, P&T Cables etc.

3. Change in designs to accommodate underground services.

4. Time taken in Soil exploration and delay in submission of designs (by the contractors) and time required for their checking and approval due to its very complicated nature.

5. Slow progress by contractors.

(d) and (e) Yes, Sir. The Lt. Governor (Delhi) has been informed that progress of the Project is already being monitored in the quarterly performance review meetings of the NBCC held under the Chairmanship of Secretary (U.D.).

#### Import of Rice

Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

(a) whether Government's attention has been drawn into the forecast made by the UN Food and Agriculture Organisation (FAO) that India might need to import some quantity of rice because of a substantial reduction in the Kharif crop this year;

(b) if so, the details thereof and Government's reaction thereto; and

(c) what does the report forecast about wheat?

**THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF FOOD AND CIVIL SUPPLIES (SHRI H. K. L. BHAGAT):** (a) and (b) Yes, Sir; the FAO's report that India may need to import some rice has come to the notice of the Government.

There is reasonable quantity of stocks of rice with the public agencies at present. However, the Government keeps open the option to import foodgrains as and when considered necessary.

(c) About wheat, FAO's Report has forecast production at 46.0 million tonnes for 1987.
