The replenishable ground water resource potential of the district is estimated at 143 million cubic metre. In Jaisalmer area, during the current year 49 tubewells are proposed to be drilled, 9 out of which have been constructed so far.

रक्षा मंत्रालय में रक्षा उत्पादन और पृति विभाग में राज्य मंत्री (श्री जिस्राज पाटिल) : (क) से (ग) 1987 के दौरान अभी तक रक्षा मंत्रालय की सलाहकार समिति की दो बैठक हुई हैं। इस सिमिति के गैर-सरकारी सदस्यों में से एक सदस्य मंत्रालय की राजभाषा कार्यान्वयन समिति की बैठकों में पर्यवेक्षक के रूप में हिस्सा लेता है।

हिन्दी अनुभाग को छोड़कर अन्य किसी अनभाग के लिये अभी यह संभव नहीं है कि वह अपना शत-प्रतिशत कार्य हिन्दी में कर सके । फिर भी इस मंत्रालय के 10 अनुभागों कारे काछ चने हुए विषयों में अपना कार्य हिन्दी में करने के लिए विनिदिष्ट किया गया है। अन्य रक्षा संगठनों दुवारा भी इसी तरह की. कार्रवार्ड की जा रही है।
