THE DEPUTY MINISTER IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI BIREN SINGENGTI): (a) While no formal assement of the 5-day-week system has been made, a quick study made by the Dept. of Administrative Reforms & Public Grievnaces in Feb., 1987 with reference to a few Ministries/Departments, did not indicate any fall in work output in terms of quantity or quality after introduction of the system.

The study did not go into the issue of increase in job capacity or production establishments.

- (b) The 5-day week system was Introduced in the Administrative offi ces in June, 1985 in consultation with the staff representatives under the Joint Consultative Machinery & Compulsory Arbitration. There has so far been no complaint from any recognised Service association in this regard.
