(a) whether it is a fact that five priceless 13th century sculptures which were sent for display in the Festival of India in several countries four years ago are yet to be returned to the Konark Museum;

(b) whether Archaeological Survey of India has repeatedly lodged protests with the festival authorities on the missing artifacts;

(c) whether the sculptures were insured and whether efforts are being made to bring them back to India intact; and

(d) whether some prized sculptures were also taken from the State Museum in Bhubaneswar and whether they have been returned since then?
