THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R. DAS MUNSHI): (a) to (c) Consequent on changes made in the Soviet Rules and Regulations permitting the set-ing up of joint ventures in the Territory of the USSR, good opportunities exist for Indian Enterprises— Both in the private and public sectors—to set up joint ventures in the USSR for mutual benefit. Already the Government have approved India Tourism Development Corporation (ITDC), a public sector undertaking to participate in a joint venture restaurant: in Moscow in cooperation with the city council of Moscow. The equity share of ITDC is Rs. 24 lakhs and the restaurant has started functioning from July, 1987 onwards.

A number of private sector firms and some public sector firms are presently examining the feasibility of setting up joint ventures in the USSR in fields such as soft drinks. leather, textiles, chemicals and dye-stuffs, wood pulp paper etc.

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY HOME **AFFAIRS** (SHRI CHIDAMBARAM): (a) and (b) No new restrictions have been imposed. However,, in crder to mitigate the chances of violations of the provisions of the Foreign Contribution (Regulation) Act, 1976 by the Honourable Members of Parliament etc they have been recently apprised of their obligations under the said Act and of the procedure for obtaining prior permission foir ^acceptance of, foreign hospitality during their visits abroad.

## Posting of Officers of CTS in Trade Missions abroad

abroad are paid their salary from th» budgetary allocations of the Ministry of Commerce;

- (f) whether Government propose to refer the case of CTS to the High powered Committee set up by it under the Chairmanship of the Cabinet Secretary for ending the discrimination; and

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI P. R. DAS MUNSHI): (a) No, Sir. However, the CTS Rules provide that CTS' Officers are liable to serve anywhere in India or outside.

- (b) Yes, Sir.
- (c) Ministry of Commerce is providing budgetary allocations only to the extent of commercial posts in the Indian Trade Missions abroad.
- (d) and (e) The Trade Missions abroad are mostly manned by Officers of the Indian Foreign Service. The Central Trade Service is a newly formulated service and the first batch of direct recruits joined the service only in 1986. As the service grows in age, suitable officers may then be available who could be considered for postings in Trade Missions abroad.
- (f) and (g) No, Sir. However, the Ministry has recently initiated a cadre review of the CTS.
