- 8. Soil conservation should continue to be a priority programme but project funds should not be used for giving loans. A proper land use policy should be developed.
- 9. There should be closer linkage among different development programmes in the rural sector.
- 10. There should be exclusive arrangements for implementing the Programme in different districts.
- 11. There should be regular evaluation of (a) specific programme activities in different projects, and (b) the entire programme in a project by State Governments. At the State level, implementation should be regularly monitored and efforts made to quantify achievements in different sectors. State Governments should constitute teams of experienced personnel of the relevant disciplines to formulate schemes for different project areas and spell out of the details of implementation.
- 12. Under the DPAP, allocations may continue to be made at the rate of Rs. 15 lakhs per block. The expenditure should continue to be shared equally between the Union and State Governments.

These would be taken up by the Ministry for financial sanction subject to merits of the proposals, availability of funds and interse priorities. No Yatri Niwases are proposed to be set up in Orissa during 1988-89 as the two Yatri Niwases sanctioned. One each $alread_y$ Konark and Satpada, are yet to be completed.
