THE MINISTER OF ENERGY AND THE MINISTER OF COMMUNICATIONS (SHRI VASANT SATHE): (a) S/Shri B. K. Gulati, Postal Assistant and Chiranji Lal Sharma, Postman expired during the year 1986.

- (b) and (c) No, Sir. Appointment in relaxation of Recruitment Rules of the dependents of the deceased Govt, servants are done after proper examination and only if the family is left in indigent circumstances. Both the cases are under examination.

Theft of Power

1989. SHRI MUKHTIAR SINGH MALIK:

SHRIMATI RENUKA CHOW-DHURY:

Will the Minister of ENERGY be pleased to state:

- (a) whether it is a fact that there have been a number of cases of theft of power all over the country;
- (b) whether it is also a fact that more than 50 per cent of power loss is due to these thefts and this is causing considerable revenue loss to the exchequer; and
- (c) what action Government propose to take to avoid the theft of power in the country?

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER IN THE MINISTRY OF ENERGY (SHRIMATI SUSHILA ROHATGI): (a) to (c) The State Electricity Boards/Departments during inspections/checkings of consumers installations have been detecting cases of theft of power. In a large system such as our, it is difficult to segregate losses on account of theft of power, and on account of other factors.

Central Electricity Authoritiv have comprehensive guidelines to the Electricity Supply Organisations for the reduction of transmission & distribution losses. The Indian Electricity Act, 1910 has been amended to make theft of power a cognizable offience. The State Gvernments/Electricity Supply Organisations been advised to intensify surprise inspection of the various consumer installations, and to undertake suitadministrative and measures for the prevention of theft of power.
