

State Govt, undertakings can put up their projects in the joint sector - in association with private parties in accordance with the approved norms. Details of such projects are, however, not centrally maintained in the Ministry of Industry.

Complaint Against M/s. Vijay Ratan Enterprises Gas Agency

(a) whether it is a fact that M/s. Vijay Ratan Enterprises, Laxmi Nagar, Delhi takes 15 to 20 days to supply LPG refills and this has been the general practice during the last six months;

(b) if so, whether any enquiry will be made and steps taken to see that LPG refills are supplied at the earliest; and

(c) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) to (c) A temporary backlog had developed since November, 1987 on account of delivery boys of this distributor going on strike frequently. The disputes have since been resolved and the backlog has **been** considerably reduced.
