

State Govt. undertakings can put up their projects in the joint sector — in association with private parties in accordance with the approved norms. Details of such projects are, however, not centrally maintained in the Ministry of Industry.

(d) As on 8-3-88, 87 and 16 industrial licence applications received for setting up of industries in Uttar Pradesh and Bihar, respectively, were at various stages of processing. Every effort is made to dispose of such applications as expeditiously as possible.

Complaint Against M/s. Vijay Ratan Enterprises Gas Agency

1888. SHRI SURAJ PRASAD: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether it is a fact that M/s. Vijay Ratan Enterprises, Laxmi Nagar, Delhi takes 15 to 20 days to supply LPG refills and this has been the general practice during the last six months;

(b) if so, whether any enquiry will be made and steps taken to see that LPG refills are supplied at the earliest; and

(c) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI RAFIQUE ALAM): (a) to (c) A temporary backlog had developed since November, 1987 on account of delivery boys of this distributor going on strike frequently. The disputes have since been resolved and the backlog has been considerably reduced.
