available. This vehicle can also be introduced at Primary Health Centre where Primary Health Centres' roads are good enough, and subject to individual choice of the State Governments.

- (c) The matter is still under consideration of the Ministry.
- (d) Purchase of vehicles under F.W. Programme is always being done on basis of recommendations made by the Technical Committee. However, in the present case, the matter is still under consideration of the Ministry.

Linking Chandigarh Ludhiana to rail

- (a) whether Government's attention has been drawn to the news item which appeared in Indian Express, Bombay of 11th September, 1987 under the caption 'Student ragged to death' in which it was reported that a boy studying in Allahabad, Agricultural Institute was ragged to death;
 - (b) if so, what are the details thereof;
- (c) whether Government intend to take cognizance of the menace of 'ragging' in colleges in which brutal and inhuman acts are committed by the senior students their junior students; and
- (d) if so, what measures including enactment of special penal penalities to deal with this menace and other steps Government propose to take to deal effectively with it?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) and (b) According to the reports which appeared in the Press, a student of the Allahabad Agricultural Institute died in early September, 1987. It was repotred that the student died as an air-gun went off accidentally hitting him in the eye. According to the relatives of the student however, were signs of physical injury on his body which suggested that the death was not due to the accident as reported. They suspect

that the student died apparently a victim of ragging. According to the Government of Uttar Pradesh, a case was registered with the local Police Station, which has since been handed over to C.B.I. for investigagation.

(c) and (d) The Government have no proposal to enact any special law to deal with the practice of ragging. However, the Government had been requesting the State Governments, Vive-Chancellors of Universities Heads of similar institutions from time to time to take effective steps to prevent incidents of ragging including summary expulsion of students found indulging in ragging their juniors.

Expenditure on Cancer Treatment

ised and printed materials distributed to educate the public on the preventive aspects of cancer.
