(c) whether Government propose to increase the amount in the coming years; if so, what are the details thereof; and

(d) by when "Operation Black Board" is likely to be completed in Madhya Pradesh?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) to (d) amount of Rs. 1194.10 lakhs under the scheme of Operation Blackboard has been sanctioned to Government of Madhya Pradesh in 1987-88 to be utilised by them. No amount has been fixed for release in 1988-99 or 1989-90 as it will be based on actual deficiency of teaching learning material and second teachers reflected in the block project reports and sanctioned by State Level Empowered Committee. As per the scheme the entire State is expected to be covered by 1990.
