Printing of skull bones and dead body on

packets of Bidi

SHRI C. RAMACHANDRAIAH (Andhra Pradesh): Sir, thank you for permitting me to raise an important issue. On 5th July, 2006, the Health Ministry of Government of India issued a notification by which every *bidi* manufacturer has to print skull bones and dead body on every packet of *bidi*. We fully support the National Health Policy, as everybody in the House supports. But the only thing is, by virtue of educating the people we should desist them from smoking. But, instead of getting educated, people are being terrorised by these advertisements. Sir, all political parties in Andhra Pradesh have agitated on this and they made representations. I do not want to politicise the issue but I would like to draw the attention of the Government and get the problem solved.

All the political parties have made representations to the Health Minister. But the Health Minister was rather reluctant to change it. Andhra Pradesh is a very big tobacco growing State. Lakhs of farmers are producing tobacco. Secondly, it is one of the biggest bidi manufacturing States in the country. Around 3.5 crore bidi workers are dependent on this for their livelihood and in Andhra Pradesh, I was told that the figure is 1.5 million. And all are poor people. Girijans are collecting *tendu* leaves from the forest for the manufacture of these bidis. It is a cottage industry and in their respective homes they can roll the bidis. This is the convenience the workers have got. They can make their living by earning Rs.60-70 by rolling a thousand

bidls. Sir, this was agitating the entire people of Andhra Pradesh. The Health Minister has gone to the Press in spite of our request. The Congress MPs too have already represented. We too have represented. Instead of consoling these MPs, he has gone to the Press saying that we are politicising the issue. I leave it to his wisdom.

Recently, the hon. Minister of Labour, Shri Oscar Fernandes has visited Andhra Pradesh because by-elections are there in a particular Parliamentary constituency - Karimnagar. In this constituency, more than 1.6 lakh bidi workers are there. So, they are trying to take advantage of it.

Sir, on this notification issued by the Ministry of Health and the visit by the Labour Minister; he has gone to the Press saying that they are prepared to change the notification and if necessary they would amend the Act. Sir, the Parliament is in Session. We made representation to the hon. Minister in Delhi. Sir, I am at liberty to question the prudence of the Labour Minister going to Andhra Pradesh and making a statement over there rather than making it here. This is the first point. Secondly, it is not confined to his portfolio.

The hon. Chief Minister of Andhra Pradesh too made a statement in Andhra Pradesh saying that he made a representation to * who happened to visit Andhra Pradesh 3-4 days back. He said that she conceded to change the notification. Naturally, everybody in the entire country is looking to her for a solution of the problem. Some political leaders, including the CPI(M), have said that instead of the Minister making that statement, she should have made that statement so that the people could have believed it. The answer came saying that since she did not hold any Constitutional post, the Minister had made the statement. Okay, when she does not have any Constitutional post, in which capacity has she inaugurated the medical college? ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: No, no. I am not allowing you to go on diverting from the issue. ...*(Interruptions)*... Please sit down ...*(Interruptions)*...

Please sit down. ...*(Interruptions)*... Mr. Ramachandraiah, you are concerned about bidi workers. ...*(Interruptions)*... Please sit down. SHRI C. RAMACHANDRAIAH: Humbly, I would like to say that this august House has to establish whether a non-Constitutional personality can inaugurate a medical college.

MR. DEPUTY CHAIRMAN: No, no. That is not the issue ...*(Interruptions)*... I don't allow you that..*(Interruptions)*... That is not the issue before us..*(Interruptions)*... The issue before us is bidi. You mention about that..*(Interruptions)*... Otherwise, I will not allow you..*(Interruptions)*... No, no..*(Interruptions)*...

SHRI PRASANTA CHATTERJEE (West Bengal): Sir. I also have something to say...*(Interruptions)*...

SHRIMATI BRINDA KARAT (West Bengal): Sir, it is a question of life and death of bidi workers... *(Interruptions)*...

MR. DEPUTY CHAIRMAN: No, no. I am not allowing other than bidi workers issue...*(Interruptions)*... At the same time, I cannot allow everybody to speak on bidi workers...*(Interruptions)*... He can associate himself... *(Interruptions)*...

SHRIMATI BRINDA KARAT: Sir, it is the issue of bidi workers...*(Interruptions)*... Sir, he is the leader of the Bidi Workers' Union... *(Interruptions)*...

Internal Security Scenario in the country - *Contd.*

श्री मंगनी लाल मंडल (बिहार) : माननीय उप-सभापति महोदय, कल मैंने भारतीय जनता पार्टी के नेता श्री अरुण जेटली का भाषण बड़े गौर से सुना था। उन्होंने कहा कि राजनीतिक दृष्टि से इस विषय पर चर्चा नहीं होनी चाहिए, लेकिन उन्होंने अपने पूरे भाषण में संघ राजनीति की और भारत सरकार द्वारा पिछले तीन-चार वर्षों के जो आंकड़े उपलब्ध कराए गए हैं, उन के बारे में तुलनात्मक दृष्टि से कोई बात नहीं की। उन्हें भारत सरकार को इस बात के लिए appreciate करना चाहिए था कि स्थिति में परिवर्तन हुआ है।

मान्यवर, यह ठीक है कि उग्रवाद व आतंकवाद की घटना से यह देश जूझ रहा है। यह बात भी सही है कि आज आतंकवाद अंतर्राष्ट्रीय समस्या है, लेकिन काश्मीर को व उत्तर-पूर्वी राज्यों को लेकर जो भारत की विशेष परिस्थिति है, उस के पीछे जो कारण हैं, उन की पृष्ठभूमि में इस पर चर्चा होनी चाहिए। महोदय, पहले तो पाकिस्तान से आतंकवादी आते थे, हम इस बात को जानते हैं और भारत सरकार ने इस बात को कई बार दुनिया को जताने का प्रयास किया है। अब दुनिया भी इस बात को जानती है कि पाकिस्तान में, पी0 ओ0 के0 में आतंकवादियों के प्रशिक्षण केन्द्र हैं। आज देश में दो तरह के प्रशिक्षण प्राप्त आतंकवादी इस देश में घुसपैठ कर रहे हैं। ये आतंकवादी पहले काश्मीर में घुसपैठ करते
