and (b) An advance Plan assistance of Rs. 45 crores and Grant-in-aid of Rs. 15 crores under Border Area Development was provided to Indira Gandhi Nahar Project Rajasthan during the period 1985 —88. As this is only an additionally it is not possible to identify the benefits separately.

No separate list District-wise in this regard is being maintained. 26 cases of participation in Arya Samaj Movemebnt are pending at present. A Non-Official Screening Committee has been set up to scrutinise such cases.
