Promotional avenues of Inspectors (Harijan Welfare) in the Directorate of Social Welfare, Delhi Administration

39. SHRI BHAGATRAM MANHAR: Will the Minister of HOME AFFAIRS be pleased to refer to the answer to Unstayed Question 1276 given in the Rajya Sabha on the 28th March, 1985 regarding posts of Inspectors in the Directorate of Welfare for SC|ST, Delhi Administration and state;

(a) whether it is a fact Chat Inspectors (Harijan Welfare) in the Directorate of Social Welfare, Delhi Administration have not been provided suitable promotional avenues so far

(b) whether it is also a fact that they were denied the promotion to the posts of Deputy Superintendent 'as the Recruitment Rules in this regard were amended; and

(c) if so, by what time the present incumbents will be given long awaited promotions?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHR1 CHINTAMANI PANIGRAHI): (a) to (c) According to the recruitment rules applicable upto 10-12-1984, the Inspectors (Harijan Welfare) were entitled to be promoted to the next higher post of Deputy Superintendent|Superintendent. These rules were revised with effect from 11-12-1984. In terms of the revised recruitment rules, the Inspectors (Harijan Welfare) ceased to be eligible for promotion to the post of Deputy Superintendent. However, the new recruitment rules proposed to be implemented provide for re-introduction of the benefit of promotions to this category.

Smuggling of heroin on Indo-Pak Border

THE MINISTER OF STATE IN THE DEPARTMENT OF REVENUE IN THE MINISTRY OF FINANCE (SHRI AJIT PANJA): (a) and (b) Reports received indicate that the Indo-Pak border continues to be vulnerable to smuggling of heroin besides charas and other contraband goods. The quantities of heroin seized in India in the last threat years where the source|origin of the drug was reported to be Pakistan are given below:

Government have initiated various aggressive counter-measures against drugtrafficking which include strengthening of the preventive and intelligence machinery, adoption of a liberalised reward scheme for officers and informers, increased co operation between variouj drug-law enforcement agencies, bilateral cooperation with Pakistan, and Regional Copperation under the umbrella of SAARC.
