Investigation into the Assets of Bachchan Brothers

*1. SHRI KAILASH PATI MISHRA:

SHRI ATAL BIHARI VAJPAYEE:†

Will the Minister of FINANCE be pleased to state:

- (a) whether the Income-tax Department and the Directorate of Enforcement are investigating into the assets, in and outside India of Bachchan brothers; and
- (b) if so, what are the findings thereof and whether notices have been issued and prosecutions launched?

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC FAIRS IN THE MINISTRY OF FINAN-CE (SHRI EDUARDO FALEIRO): (a) and (b) The Directorate of Enforcement is conducting investigations into a case of alleged FERA violation against Ajitabh Bachchan, As part of the porcess of completing assessment of income tax and wealth tax of SShri Ajitabh Bachchan and Amitabh Bachchan, the Income Tax Department has called for certain information regarding details of property acquired by both the above individuals. These investigations are in progress.

श्री ग्रटल बिहारी वाजपेयी: सभापति जी, सरकार ने . . . (व्यवधान)

SHRI JAGESH DESAI: I am on a point of order (Interruptions)

†The question was actually asked on the floor of the House by Shri Atal Bihari Vajpayee.

SHRI V. NARAYANASAMY: It is a question of a point of order. He may be allowed to speak (Interruptions)

SHRI RAOOF VALIULLAH: There is a precedent for raising a point of order during the Question Hour (Interruptions)

SHRI M. S. GURUPADASWAMY: Mr. Chairman, may I know whether you have allowed him to raise the point order? (Interruptions)

SHRI RAOOF VALIULLAH: In the last Session, the Opposition did it. At that time the rules did not apply (Interruptions)

MR. CHAIRMAN: Kindly sit down. There is the practice that no point of order is permitted in the Question Hour. (Interruptions)

SHRI RAOOF VALIULLAH: In the last Session, you permitted them. (Interruptions) This is not fair. In the last Session, we raised the same question. You permitted them (Interruptions)

MR. CHAIRMAN: Kindly permit House to proceed (Interruptions)

SHRI RAOOF VALIULLAH: In the last Session we raised the same issue. You permitted them to raise a point of order. (Interruptions)

SHRI LAL K. ADVANI: You have given your ruling, Mr. Chairman. Please stick to it. (Interruptions)

SHRI DIPEN GHOSH: The ruling of the Chairman has to be honoured. (Interruptions) Why are you so sensitive? Whom are you trying to shield? (Interruptions)

' MR. CHAIRMAN: I request the hon. Members not to cast aspersions on each other. So far as this question is concerned, as I told you, there is a convention that points of order are not permitted during the Question Hour, I was thinking that there could be questions and the whole thing could be thrashed out and I don't think anybody is interested on any side of the House in shielding anybody. Let us not cast aspersions against ourselves because all Members are one. Our prestige is important. Let us go on with the questions. The motive should not be questioned either by this side about that side or by that side about this side.

SHRI NIRMAL CHATTERJEE: For our collective prestige we should see that nobody is shielded and no one is shielding. That is what we have to ensure in this House.

SHRI JAGESH DESAI: I would like to make a submission ...

MR. CHAIRMAN: I have said just now that there is no point of order.

SHRI DIPEN GHOSH: Mr. Shiv Shanker, you mean calling a person a friend is an aspersion? You call one as a friend and that is an aspersion?...(Interruptions)...To call one as a friend is an aspersion? What are you saying?...

SHRI P. SHIV SHANKER: You please hear me... (Interruptions)... What I was saving was that you must hear me. After all, you have asked me. Am I not entitled to reply? ... (Interruptions) ...

SHRI LAL K. ADVANI: Let the supplementaries go on first...(Interruptions)

SHRI MURASOLI MARAN: Who is asking and who is replying, Sir,? ... (Interruptions) ... We do not know who is asking and who is replying...(Interruptions) ...

SHRI PARVATHANENI UPENDRA:
How can he reply, Sir? Let the Finance

How does Mr Shiv Shanker came into the

SHRI P. SHIV SHANKAR: You ask your colleague, Mr. Gurupadaswamy..., (Interruptions)... You ask him why he asked me. Why did he ask me?

SHRI PARVATHANENI UPENDRA: It is unfortunate that he is his friend. Not our raying. (Interruptions) SHRI EDUARDO FALEIRO: I have listened with great patience and most quietly to what Mr. Vajpayee had to say... (Interruptions)

SHRI DIPEN GHOSH: It is unfortunate for all of us that the Prime Minister is having friendship with FERA breakers. (Interruptions)

SHRI EDUARDO FALEIRO: There is the directive of the Prime Minister. The directive of the Prime Minister was very clear that if anybody is proved to be guilty—whosoever he may be—then action should be taken against him We are working in that direction in our Ministry, and we shall continue to abide effectively by that directive. (Interruptions)

AN HON. MEMBER: There is no conviction with anybody.

MR. CHAIRMAN: So far as this House is concerned, it is not interested in any individual this way or that way. That is obvious. Secondly, this House is interested in seeing that our laws are not violated. These two things are there.

SHRI N. K. P. SALVE: Which is the law?

MR CHAIRMAN: So far as I am concerned, my job is to see that questions are asked and questions are answered. What questions are asked and what supplementaries are put depends upon the Members concerned and the Ministers concerned. So far as I am concerned, this particular question about which body should inquire is a relevant question. I have no doubt that what he has said is important because he is an expert.

SHRI EDUARDO FALEIRO: Sir, I will repeat what I have said Shri Ajitabh Bachchan has made statements and there is no question of....

We do not consider that it is necessary to impound the passport of Shri Ajitabh Bachchan because he has been fully co-operating with the inquiry. Now, further ... (Interruptions) Will you kindly just look at the answer that we have given? (Interruptions)

SHRI PARVATHANENI UPENDRA: The Government is co-operating with him.

MR. CHAIRMAN: You just listen to him

SHRI M. S. GURUPADASWAMY: Who is co-operating with whom? Is the Government co-operating with him? (Interruptions)

MR. CHAIRMAN: Opposition is cooperating with the Government in finding out the facts. (Interruptions) This side and that side are co-operating with each other with a common objective. Both are cooperating. I believe they will always cooperate...

SHRI LAL K. ADVANI: If it is co-operating in shielding the corruption, it cannot....

MR. CHAIRMAN: I am only referring to the co-operating in finding out the guilty flighting against the evils. So, I hope, in this at least there are no two opinions, both sides are one.

SHRI N. E. BALARAM: Sir, there is one question. If the Bachchans are cooperating why should he send an officer to Switzerland?

MR. CHAIRMAN: He is not sending any officer. He said 'no'. You can ask a supplementary later.

SHRI EDUARDO FALEIRO: Sir, I am afraid, the hon Member has not paid attention to what I have said in my original answer which is a written answer. I have said it here that the Directorate of Enforcement is conducting investigation, and these investigations are in progress.

AN HON. MEMBER: How long?

SHRI EDUARDO FALEIRO: Now, Sir, the Members know and the House knows-hon. Chairman, if it is necessary, you can give your ruling-that the law is very clear that under Section 44 of FERA and similarly under the concerned Section of the Income-tax Act, when these investigations are in progress, confidentiality is to be maintained because otherwise purpose of investigation will be defeated.... (Interruptions) Sir, I have been so far giving all the information I can. I shall continue to give all the information that I can. But I cannot give information which is forbidden be given under the Rules of this House, namely Rule 47 (xix) of this House, and Section 44 of FERA and the corresponding Section in the Income-tax Act. So, as the investigation is in progress, it will prejudice the investigation to give the details. I will not be in a position

MR. CHAIRMAN: His question is whether he has declared himself a Non-Resident Indian on 3rd April. If you know and if you have got the information now, the pointed question here was whether he declared himself a Non-Resident Indian on 3rd April Which year?

SHRI ATAL BIHARI VAJPAYEE: 1986.

SHRI LAL K. ADVANI: 1986 to justify the purchase of that ilat.

MR. CHAIRMAN: That was the first question. If he has done it, is there any bar to his continuing as a Director here? I do not know whether you are prepared with it....

SHRI EDUARDO FALEIRO: Sir, as I have said, the question whether a person is a Non-Resident Indian or not is both a question of fact which decends upon evidence and it is also a question of law (Interruptions).

MR. CHAIRMAN: You need not answer his question. He is not entitled to ask at this time.

SHRI EDUARDO FALEIRO: of course, he is not. I wanted to put it

politely...

SHRI ATAL BIHARI VAJPAYEE: I
want to know whether Ajitabh Bachchan

declared that he became a non-resident Indian on the 3rd of April, 1986. Whether that claim is correct or not?

that you are investigating his status...

MR. CHAIRMAN: Your answer

SHRI EDUARDO FALEIRO:... and the law prevents me...

MR. CHAIRMAN: The law cannot prevent you from investigating his status.

SHRI EDUARDO FALEIRO: The law prevents me from disclosing the investigations which are in progress.

MR. CHAIRMAN: The question

very simple. He does not want you to divulge. He wants to know whether in the eye of the Government of India, in your own eye, he is a Non-Resident Indian, or what is his status. (Interruptions). Please hear me. I think your answer is—if it is not correct, you correct me—that this is not determined as yet. Is it correct?

SHRI EDUARDO FALEIRO: That is one side of it.

MR. CHAIRMAN: What i_S the other side of it?

SHRI EDUARDO FALEIRO: That is one side of it. The other side...

MR. CHAIRMAN: There can be only one side. Either he is a Non-Resident Indian or he is not a Non-Resident Indian

or the matter is under investigation. Now you cannot have a fourth thing. (Interruptions).

SHRI DIPEN GHOSH: Why are you helping him?

MR. CHAIRMAN: I asked him, if he is prepared for it, he will answer. He started answering.

SHRI EDUARDO FALE!RO: Now I will repeat it again, Sir.

SHRI M. S. GURUPADASWAMY: To claim or not to claim depends upon anybody's convenience. You are exposing the Government. Let me tell you that you are exposing the Government.

SHRI ALADI ARUNA alias V. ARU-NACHALAM: We want to know the exact date on which he became a Non-Resident Indian?

SHRI VISHVIIT PRITHVIIT SINGH: For Heaven's sake do not level charges against the investigating officers. Please keep quiet about this and let the investigation be over.

SHRI VIRENDRA VERMA: Have you allowed him, Sir?

SHRI VISHVJIT PRITHVIJIT SINGH: Let the investigation be over and then talk about it. Do not talk about it now. This is not the sort of investigation we expect.

SHRI M. S. GURUPADASWAMY: They have already taken seven to eight months so far to investigate one particular case.

MR. CHAIRMAN: You may ask questions when your turn comes. Now, I think the basic presumption of democratic form of Government is that we believe that when they come in Parliament, whichever side, nobody thinks of convenience. Let us not get into that point.

SHRI ANAND SHARMA: I have to ask one question. Mr. Vajpayee said about an NRI continuing as a Director of

Indian companies. My question is, is there any legal ban or bar? That is what he is hinting at ... (Interruptions). Let me clarify your confusion about the law.

Urui Answers

SHRI DIPEN GHOSH: Sir, he is not the Minister.

SHRI ATAL BIHAR! VAJPAYEE: Sir, what about my question?

MR. CHAIRMAN: You ask your friends not to interrupt

SHRI M. S. GURUPADASWAMY: Let there be a full-time debate.

PROF. C. LAKSHMANNA; I have a question to ask,

MR. CHAIRMAN: I have not called you. Please sit down. As some people have said in the House everybody seems to be interested in shouting and not in facts. Let the prestige of the House be maintained.

PROF, C. LAKSHMANNA: But my point is different.

MR. CHAIRMAN: But that is not permitted.

Coming back to the question, the question was very simple. The question was whether he has claimed to be a Non-Resident Indian. If you have got the answer you may give.

SHRI EDUARDO FALEIRO: Sir, under section 44 of FERA I cannot disclose the information that we get in the course of investigation... (Interruptions).

SHRI PARVATHANENI UPENDRA: Sir, we want your protection.

SHRI EDUARDO FALEIPO: If you give a ruling that I disclose it, I will do that.

MR. CHAIRMAN: I am not talking about disclosing it. I am familiar with the law and I do not think the answer to this question whether he has claimed to be a Non-Resident Indian comes under any prohibition

of the law. That is why I said if you have got this information, you may answer; otherwise you may not. That is all.

to Questions

SHRI EDUARDO FALEIRO: I have said that I am barred by section 44 of FERA in answering this question. (Interruptions).

MR. CHAIRMAN: How can your answer, whether he has claimed to be a Non-Resident Indian or not claimed, be barred?

SHRI EDUARDO FALEIRO: Sir, since you have ruled...

MR. CHAIRMAN: I have ruled very clearly.

SHRI EDUARDO FALEIRO: I will disclose the information. The answer is 'Yes'. He has claimed to be a non-resident Indian.

MR. CHAIRMAN: That is all.

SHRI ATAL BIHARI VAJPAYEE: Sir, the hon Minister has not replied to the latter part of my question. The hon. Minister has just now said that Mr. Bachchan has claimed to be a non-resident. In that case, I would like to know whether the Government have verified this claim. (Interruptions) This was the second part of my question. (Interruptions)

MR. CHAIRMAN: I have myself separated this question into two parts. In regard to the first part, I have ruled and the question has been answered. But so far as investigations are concerned, there is a fundamental rule of law which governs the disclosure. They will not disclose because of another reason and the reason is, we have got advocates like Mr. Bhandare and other who are very clever...

SHRI ATAL BIHARI VAJPAYEE: They are on the other side.

MR. CHAIRMAN: That is why you should be afraid of them. They will say that the whole investigation has been prejudiced and they will always take advantage of the weakness of the judiciary to hold a person guilty only when it is proved. You should be afraid of them. Please

remember. You should always be careful.
You should be afraid of these advocates
who will say...(Interruptions)

SHRI BUTA SINGH: Advocates go by the rule of law. (Interruptions)

MR. CHAIRMAN: They would not mind it. (Interruptions)

SHRI ALADI ARUNA alia_s V. ARU-NACHALAM: Sir, this is not a judicial enquiry. Thi_s is a departmental enquiry. It is not sub judice. (Interruptions)

MR. CHAIRMAN: Mr. Aruna, the whole trouble is that you are in the habit of not hearing the other side. This goes to the extent that they are not hearing what the Chair is saying. As I said earlier, as far the first part of the question is concerned, it should be answered and it has been answered. But this type of thing can be harmful in the sense that it could be said that it may be prejudiced. That is why I have permitted the first question. Now, Shri Kailashpati Mishra.

SALVE: Sir, as I read the question, it is a question which seeks information on investigation by the Incometax Department and the Directorate Enforcement into the acquisition of assets by the Bachchan brothers and if so.... (Interruptions) Sir, Mr. Jaswant Singh is always irrelevant. He is interrupting without any rhyme or reason when his leaders are listening to me quietly devoid of any discipline. Sir, if I have understood the question correc'ly. question was whether the Income-tax Department and the Directorate of Enforce ment are enquiring into the assets of the Bachchan brothers and if so, what are the findings thereof and whether notice has been issued and prosecution launched Sir, in the Income-tax Act 1961, there Chapter XIII. I am sure the Ministers are conversant with this. Chapter 13 there is a section 116(c) which refers to 'Director' as one of the investigating authorities. There is a Director of Inspection Now, if this question relates to such enquiries, firstly I must submit that this kind of question being asked prejudices the right of a person whom the question is being asked in Parlia-This is very unfair. against the basic norms of democracy that we do something against someone who is being tried in a quasi judicial proceeding. Totay it is Amitabh Bachchan, tomorrow it might be Jaswant Singh or it might bo anybody else.

SHRI ALADI ARUNA alia_s V. ARUNACHALAM: It is not the question of Amitabh Bachchan as such, it is a question against the economic offenders. (Interruptions).

SHRI N. K. P. SALVE: I am not worried about Amitabh Bachchan's friendship with our Prime Minister because I know my leader he is a steadfast and honest If somebody is guilty, he will be punished not once but 20 times. (Interruptions). He was a Member of our party, a decent member of the party. He is a citizen of the country and as such he is entitled to all the protection of the law. submit very respectfully that a question of this nature, if admitted, prejudices the right of the person who is being tried in a quasi judicial proceeding, (Interruptions), My question therefore is whether there is any prima facie cases whatsoever against. the Bachchan brothers under the Incometax Act. If there are any assets acquired, they are liable to be included in the total income. So, I would like to whether there is any such enquiry against Bachchan brothers. And if there is some enquiry, have they any findings, because before reaching any findings there prosecution cannot be launched? Section 1

MR. CHAIRMAN: You want to know whether there is proceeding ...

SHRI N. K. P. SALVE: Under the Income-tax Act.

AN HON. MEMBER: Under FERA.

SHRI N. K. P. SALVE: It does not relate to FERA. There is a director. I have made a reference to the section itself. There is a director of investigation for enforcement purposes. So, I want to know whether under the Income-tax Act there is any enquiry or there is any prima facie case; if it is there whether the enquiry has been completed. If it is not completed, how can the notice of prosecution be issued?

SHRI EDUARDO FALEIRO: Sir, I must say that there is no evidence at all of commission of any offence under the Income-tax law either by Amitabh Bachchan or by Ajitabh Bachchan

SHRI ALADI ARUNA alias V. ARU-NACHALAM: This is the document which shows that they have purchased a property in Switzerland. Do you tank there is no prima facie case? How can you say that? If there is no prima facie case, why are

MR. CHAIRMAN: The question is whether there is an enquiry under the Income-tax Act. What do you say about

they having enquiry for seven months?

(Interruptions).

that?

SHRI EDUARDO FALEIRO: Since there is no prima facie case, there is no enquiry, there is only usual assessment of returns which is the usual thing. There is no indication of commission of an offence under the Income-tax Act.

MR. CHAIRMAN: So, there is no enquiry, you are only making a preliminary assessment.

THE MINISTER OF STATE IN THE MINISTRY OF LAW AND JUSTICE (SHRI HANS RAJ BHARDWAJ): There is a difference between assessment...(Interruptions).

SHRI N. K. P. SALVE: It is only assessment. I am liable to be assessed, he is liable to be assessed under the Income-tax

to Questions

SHRI HANSRAJ BHARDWAJ: May I submit? There are two things. Under the Income-tax Act one has to be assessed. Under FERA one has to be enquired into. These two matters are quite separate. Under Income Tax Act, the hon. Minister has said that assessment of the various years is going on and an enquiry and preliminary investigation are going on. This is premature and he does not find any justification for this type of insinuation.

MR. CHAIRMAN: Assessment is going on, but not under FERA. That difference is there.

SHRI N. K. P. SALVE: That is what I was submitting. The question is clearly under the Income Tax Act and the hon. Minister is replying under the FERA.

SHRI HANS RAJ BHARDWAJ: No.

SHRI N. K. P. SALVE: He is. He is asking under FERA and he is replying under FERA. If the question is under Income Tax Act, this ought to be the conclusive answer.

MR. CHAIRMAN: Not being an income-tax man or a FERA man, I do not know it. You are an expert.

SHRI N. K. P. SALVE: Sir, I want you to go by the question, as it is framed and as I have submitted—I have got the book here—there is a Directorate of Inspection/Investigation under the Income Tax Act. FERA is not under the Income Tax Act. FERA is a diffrent thing. Therefore the only relevant answer to a relevant question could be an enquiry under the Income Tax Act and the answer should have been a big 'No'

SHRI ALADI ARUNA alias V. ARUNACHALAM: The question is about Income Tax Department and the Directorate of Enforcement. Directorate of Enforcement is under FERA. Kindly go through the second part of the question. It is a question about Income Tax

as well as FERA violation. What about enforcement?

SHRI M. S. GURUPADASWAMY: The question refers to—may I read it?—assets acquired by Bachchan brothers in and outside India.

SHRI N. K. P. SALVE: Please let me know one thing—whether the question is under the Income Tax Act or under the Foreign Exchange Regulation Act?

SEVERAL HON, MEMBERS: Both.

SHRI ALADI ARUNA alias V. ARUNACHALAM: Mr. Salve, we are sorry for your clients.

SHRI A. G. KULKARNI: Just listen to me, Sir.

SHRI A. G. KULKARNI: Mr. Vajpayee having not paid any income tax so far, does not understand what is FERA and what is income tax. The point is, there are two questions. One is under the Income Tax Act.

MR. CHAIRMAN: Mr. Vajpayee does not believe in accumulation of wealth.

SHRI A. G. KULKARNI: Has he ever paid anything under the income tax? The Minister has said that under the Income Tax Act, there is no case; under FERA an enquiry is going on and he is not going to disclose anything under section 44. Have you paid any income tax. Mr. Vajpayee?

MR. CHAIRMAN: He is not liable to pay income tax.

SHRI M. S. GURUPADASWAMY: Sir, the question relates to illegal assets accumulated by Bachchan brothers, both inside and outside India. So both Income Tax Act and FERA are covered.

MR. CHAIRMAN I want to know, please, both of you can tell me, the question is about what?

SHRI DIPEN GHOSH: One is about violation of FERA and the other is about violation of Income Tax Act.

SHRI A. G. KULKARNI: Then you should have said under Foreign Exchange Regulation Act. The Directorate of Enforcement is under Foreign Exchange Regulation Act. Sir, the question is not correctly framed.

श्री बूटा सिंह: पुरुता तो यह पड़ेगा कि वाजपेयी जी के किस मित्र ने यह क्वेश्चन ड्राफ्ट किया है।

SHRI A. G. KULKARNI: One must know what he is asking. He does not know properly what he is asking.

MR. CHAIRMAN: Will you please permit some time for me also? I want to know whether the question is relating to Income Tax Department or the Directorate of Enforcement.

SHRI A. G. KULKARNI: Sir, it is wrongly drafted.

SHRI EDUARDO FALEIRO: The question is for both—it relates to FERA as ${\rm fa_r}$ as the flat is concerned and Income Tax Act as far assets are concerned.

MR. CHAIRMAN: I am an ignorant man as far as financial laws are concerned. So, I want to know whether it is the Income-tax Department or the Directorate of Enforcement.

SOME HON. MEMBERS: Both.

SHRI N. K. P. SALVE: Sir, all F submit is, there is a Directorate under the Income-tax Act also....(Interruptions).. If there is a Directorate under the Income-tax Act, all that I want you to rule is whether according to you, the question is under the Income-tax Act or under the Foreign Exchange Regulation Act.

MR. CHAIRMAN: It can be under both...(Interruptions)...

SHRI NARAYAN DATT TIWARI: Sir, I would submit that.. (Interruptions)

Of course, the question itself has been rather ill-drafted—there is no doubt about it. But, understanding the spirit of that, not the words, we have tried to answer the question.

Oral Answers

SHRI A. G. KULKARNI: Then why are you replying?

MR. CHAIRMAN: Out of consideration for these. (Interruptions)...

SHRI NARAYAN DATT TIWARI: First is the investigation into the case of alleged FERA violation against Ajitabh Bachchan and Shri Amitabh Bachchan. This being a subject-matter coming under the ambit of the FERA, is being dealt with by the Directorate of Enforcement and they are investgating into the matter. Secondly, as far as the question of income tax and wealth tax of Shri Amitabh Bachchan is concerned, that is being dealt with by the Incometax Department. It has been very clearly mentioned that they have called for certain information regarding details of property acquired by both the above-mentioned individuals. These investigations are in progress. The answer is very clear and I think it meets the substance of the question.

MR. CHAIRMAN: It looks, instead of going into the literal meaning of all that. They have tried to give whatever was within their knowledge. (Interruptions).

SHRI DIPEN GHOSH: Sir, I want to put a very specific, pointed question. Since both the senior Minister and the junior Minister have stated that inquiries are going on, I want to know whether pending a probe, the Prime Minister's continued association with the Bachchan brothers does not amount to influencing the process of investigation...(Interruption)...

SHRI NARAYAN DATT TIWARI: May I ask...

SHRI DIPEN GHOSH: Pending a probe under law, does not the Prime Minister's continued association with the Bachehan brothers, including holidaying, amount to influencing the process of investigation?....(Interruptions).

MR. CHAIRMAN: The question is irrelevant.. (Interruptions)...

SHRI DIPEN GHOSH: That is more important, Sir. You know that a Government official is debarred from associating himself with any person who is under a cloud. Therefore, the Prime Minister cannot be above the law. I want to know whether the Prime Minister's continued association with such economic offenders does not amount to influencing the process of law. That is my question.

MR. CHAIRMAN: It is irrelevant. That a man like Mr. Dipen Ghosh....

SHRI PARVATHANENI UPENDRA: Sir, We want a special, one-hou_r debate on this ... (Interruptions). We want a special discussion on this... (Interruptions)

MR. CHAIRMAN: No, No, please.

SHRI A. G. KULKARNI: Sir, Mr. Ghosh should not go on record. ...

(Interruptions)...

MR. CHAIRMAN: Shri Gurupadaş-wamy.

SHRI M. S. GURUPADASWAMY: May I know, Sir...

SHRI DIPEN GHOSH: My question is important, Sir.

MR. CHAIRMAN: Your question is irrelevant.

SHRI DIPEN GHOSH: That is more important, Sir.

MR. CHAIRMAN: Your question is totally irrelevant. You cannot raise everything. No.

SHRI DIPEN GHOSH: It is a fact, Sir, (Interruptions)

MR. CHAIRMAN: I will not permit.

SHRI ALADI ARUNA alias V. ARUNACHALAM: Incidentally the Prime Minister is here. That is why we are asking.

MR. CHAIRMAN: His being here does not justify asking anything. Question Hour is over.
