Himsagar Express

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) and (b) Himsagar Express was cancelled in the process of making Kerala Express a daily service. It has now been decided to provide a direct weekly train between Jammu Tawi and Kanyakumari by extending 17/18 Jammu Tawi-Madras Express to Kanyakumari, it will be called the Himsagar Express.

Night Blindness in Rajasthan and Gujarat
