Railway Link between Kadur and Mangalore

2999. SHRI D. B. CHANDRE GOW-DA: Will the Minister of RAILWAYS be pleased to state:

- (a) whether there is any proposal under Government's consideration to have a railway link between Kadur and Mangalore:
- (b) if so, when was it proposed by the Karnataka Government; and
- (c) what is the stage at present and the number of times survey conducted in this regard and the action taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI 4AHABIR PRASAD): (a) No. Sir.

(b) and (c) The then Mysore Government had been conducting surveys for construction of rail line between Kadur and Chikmagalur since 1893. Last survey for this line was done in 1983-84. Survey for Kadur-Chikmagalur-Sakleshpur (a station in Ariskere Mangalore line) was conducted in 1955 to 1957. Construction of this rail line has not been approved.

Declaration of Bangalore-Mysore road as Express road

.3000. SHRI D.B. CHANDRE GOWDA: Will the Minister of SURFACE TRANS-PORT be pleased to state:

- (a) whether it is a fact that Karnataka Government have sent a proposal to the Central Government to convert the existing Bangalore-Mysore Road into Fast Express Road keeping in view the importance of these cities;
- (b) whether Government have examined the proposal and if so, the reaction thereto; and
- (c) by when the Bangalore-Mysore Road will be declared as Fast Express Road and necessary facilities will be provided?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT); (a) to (c) The

Government of Karnataka have projected the requirement for the declaration of this Road as a National Highway. However owing to constraint of resources and other priority considerations, it has not been possible to accede to there request.

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) An amount of Rs. 130 crores in the Central Sector and Rs. 230 crores in the State Sector have been earmarked during the seventh plan under Adult Education.

(b) The amount of grant released in the Central Sector and the allocation made
