## Halt of Kerala Express at Faridabad

2986. SHRI M. A. BABY: Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government are considering the request to have a halt for the Kerala Express in Faridabad, considering the fact that lakhs of Keralites and South Indian live and work in and around Faridabad; and
- (b) if so, by when the halt of this train is going to be effective and if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD): (a) No, Sir.

(b) Being a long distance Superfast and to avoid inconvenience to through passengers, the halt is not considered justifiable.

## Train Services between India and Pakistan

2987. SHRI B. SATYANARAYAN REDDY: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether any agreement was signed at a joint meeting of senior Railway officials of India and Pakistan to improve train services between the two countries; and
- (b) if so, what are the details thereof and outcome of the meeting?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MAHABIR PRASAD): (a) It was a coordination meeting at the end of which agreed minutes were signed by Northern Railway & Pakistan Railway authorities.

- (b) The following are some of the main agreed points:—
  - (i) 207 208 I.P. Expres<sub>8</sub> presently running to different set<sub>8</sub> of timings in different part<sub>8</sub> of the year will be run t<sub>0</sub> a common schedule throughout the year and the load of the train will be increased t<sub>0</sub> 14 bogies.
  - (ii) The question of increasing the frequency of Attari Express from three days a week at present to daily would be examined.
  - (iii) The question of giving up the present practice of cancelling train nos. 207|208 on the days pilgrim specials are run would be examined.
  - (iv) The clearance of parcels would be expedited.
  - (v) Karachi City and Moradabad would be added to the existing list of stations for through booking of Indo-Pakistan traffic from an agreed date to be notified.
