# Passenger facility at Railway Station in Bihar

## Implementation of "Operation Black Board" in Bihar

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIL. P. SHAHI): (a) to (d) According to the information available with the Ministry, Bihar has conducted a special survey in 120 Blocks and 39 Urban areas to ascertain the number of single teacher schools in these areas and availability or deficiency of items to be provided under the scheme of Operation Blackboard in the primary schools in 1987-88. The block project reports have been prepared to be placed before the State Level Empowered Committee to recommend the State's proposals to the Ministry of Human Resource Development for release of Central assistance. The recommendations of this Committee are still awaited.

#### **Ancient Monuments in Bihar**

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DB-VELOPMENT (SHRI L. P. SHAHI): (a) A list of monuments and sitea

declared to be of national importance in Bihar is attached. [See Appendix CXLV, Annexure No. 9]. The ancient and historical monuments which are more than 100 years old at the time of their consideration for protection and which are found to be of national importance in view of their outstanding archaeological, historical and architectural value are declared protected under the Ancient Monuments and Archaeological Sites and Remains Act, 1958, while in respect of remaining the respective State Governments are concerned.

- (b) No, Sir.
- (c) Besides looking after their day to day maintenance and upkeep structural repairs, chemical preservation are carried out from time to time according to their individual requirements.

## Conference of Kendriya Vidyalaya-Principals

- (a) whether it is a fact that a two day conference of Kendriya Vidyalaya Principals On primary education was held on 15th and 16th January, 1988 at New Delhi; and
- (b) if so, what are the details of the recommendations made by the Conference and what is Government's reaction thereon?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) Yes, Sir. The Kendriya Vidyalaya Sangathan organised a conference of Principals of Kendriya Vidyalayas in Bhopal, Jammu, Hyderabad and Delhi Regions on 15th and 16th January, 1988.

- (b) The recommendations made by the Conference are:
- (1) Only three subjects should be taught at the primary classes in Kendriya Vidyalayas:
  - (i) Hindi (ii) English
  - (iii) Arithmatic

Teaching of environmental studies should be merged with the languages.

- (2) No home-work need be assigned to the children in classes I and II,
- (3) Arithmatic exercises may be done in the school under the supervision of the teachers.
- (4) Children should be encouraged to borrow books from Library and read at home. The books may be both informative and interesting.
