(c) what are the plans to stop collection of capitation fees by schools and colleges under the new education policy?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATION AND CULTURE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI L. P. SHAHI): (a) The Government have issued suitable instructions to the State Governments and the Union Territories to present the collection of capitation fees by Technical and Medical institutions. Legislative measures have also been taken to stop the practice of collecting capitation fees. The All India Councillor Technical Education Act, 1987 passed by Parliament and the proposed amendment to the Indian Medical Council Act, 1966 which is already under consideration of the Joint Committee of the Parliament, tinier alia include provisions to prohibit collection of capitation fees. Some of the States have also enacted laws in this regard.

- (b) The Government is aware of the fact that certain private technical and medical institutions are charging high tution fees.
- (c) The All India Council for Tech nical Education Act, 1987 has been passed m pursuance of the objectives of the New Education Policy and 'as already stated in reply to part (a) of the Question, this Act contains pro visions for prohibition of collection of capitation fees.

#### Development of Water Transport in Rivers Narmada and Tapti

186. SHRI VITHALBHAI MOTIRAM PATEL: Will the Minister of SURFACE TRANSPORT be pleased to refer to reply to Unstarred Question 1967 given in the Rajya Sabha on the 25th November, 1987 and state the time by when Government propose to declare Narmada and Tapti as National Waterways?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE

TRANSPORT (SHRI RAJESH PILOT): For declaration of a waterway as a National Waterway, hydrographic survey and technoeconomic studies are some of the prerequisites. The techno-economic study On Narmada has been taken up with the Dutch Assistance and is partly completed. Howevery hydrographic surveys on Narmada is feasible only on completion of four major dams which are contemplated at Narmada Sagar, Omkaresh-war, Maheshwar and Sardar Sarovar. As regards Tapti, the hydrographic survey and the techno-economic study are not part of the VII Plan and therefore it is not possible now to indicate the time by which it will be declared as a National Waterway.

# Incidence of Japanese Encephalitis in the country

Plan scheme for providing assistance
for the control of Japanese Encepha
litis. However, the following
assistance has been provided to the
affected States: —

1. Insecticides namely DDT BHC are supplied under NMEP (Rural) on 50:50 cost sharing basis for insecticidal spray in an

- area 2-3 km around a case wherever reported.
- 2. Fogging/ULV machines have been supplied by NMEP to affected areas.
- 3. Publicity/Health Education material.
- 4. Vaccines (Imported) had been supplied to the States by National Institute of Communicable Diseases (NICD) on limited scale.
- 5. Indigenous vaccine produced at Central Research Institute, Ka-sauli, is being provided free of cost to the affected States for field trial purposes.
- 6. National Institute of Virology, Pune; School of Tropical Medicine, Calcutta, All India Institute

of Hygiene and Public Health, Calcutta and National Institute of Communicable Diseases, Delhi are involved in the programme for advice/diagnosis of cases.
