## Growing Death Kate of Children in the Country

183. SHRI GAYA CHAND BHUYAN; Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that according to the UNICEF Report-1987, the number of children who died in India during the past two years was much more than in most of the African nations;

(b) if so, what is the state of health of children in India in the age group of 0-7;

(c) what is the number of children who died in India in 1987; and

(d) what preventive methods as suggested by WHO have been taken to check growing death rate of children in India?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (KUMARI SAROJ KHAPARDE) (a) and (b) According to "The State of the World's Children 1987" published by UNICEF, under-5 child mortality rate in India is more than some of the African countries and India ranks 40th amongst the list of 130 countries.

(c) The estimate of children died in India in 1987 is not available. The latest available number of estimated deaths amongst children in the country in age group 0-4 years as obtained from SRS Registrar General of India for the year 1984 is 37.4 lakhs.

(d) The steps taken by Government of India to reduce child mortality in- j elude improvement of health infrastructure, training of health manpower, health education adoption of "risk approach", universal immunisation of children, oral rehydration therapy in diarrhoeal diseases, promotion of breast feeding and proper weaning; practices, prophylaxis against nutritional anaemia and supplementary nutrition under I. C. D. S. Scheme.
