## Anticipated gap between demands and supply of drinking- water within Delhi by 1991 and 2001

- (a) what are the areas of Delhi most affected with the shortage of drinking water supply;
- (b) what is the anticipated rise in the demand of drinking water by 1991 and 2001 and with the existing source of drinking water and the rate of growth in the city's population, what is the anticipated gap between demand and supply by 1991 and 2001; and
- (c) what is the strategy, if anv, formu lated by Government *tO* meet the city'i drinking water demand to the maximum?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH); (a) DWS&SDU have reported that areas situated at the tailend of the distribution system and some of pockets situated at higher elevation face some shortage of water during summer months. Some curtailment of water in the areas falling under the command of Wazirabad and Chandrawal Water Treatment Plants has also taken place due to present shortage-.

(b) and (c) The assessed requirement of water in Delhi by 1991 is 592 mgd and 1024 mgd by 2001. The anticipated gap between demand and supply during the said years cannot be anticipated at this stage. Govt, is maintaining a continuous liaison with the State Govts, of U. P. & Haryana with a view to taking such steps as may be practicable for maintaining supply of water to the city as close to the demand as possible.
