(b) Government has taken a number of measures to contain rise in the prices of essential commodities and improve their availability. The main thrust' Of the Government policy has been to increase production of various essential commodities, particularly those which are in short supply. Other measures include import of some lessential commodities to augment domestic supplies, regulating export of some essential commodities, strengthening and expanding the Public Distribution System and strict enforcement of provisions of Essential Commodities Act and similar legislationsagainst hoarders, black-marketeers by the State Go-vernment/UT Administrations.

On account of widespread drought conditions prices in general have been under pressure. To meet the situation, Chief Ministers of States and Lt. Governors of Union Territories have been urged from time to
