THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURAL RESEARCH AND EDUCATION IN THE MINISTRY OF AGRICULTURE (SHRI HARI KRISHNA SHASTRI): There is no Institute under the ICAR named as Central Plant and Crop Research Institute at

Mohitnagar in West Bengal. However, there is an Institute named as Central Plantation Crops Research Institute located at Kasaragod (Kerala) with a Research Centre at Mohitnagar, Jalpaiguri in West Bengal and information is as under:—

THE MINISTER OF STATE IN THE DEPARTMENT OF FERTILIZERS IN THE MINISTRY OF AGRICULTURE (SHRI R. PRABHU): (a) Yes, sir,, consultants have since been appointed for carrying out an end-to-end suvrey of the Haldia fertilizer project; and

(b) The report of the consultants is expected by May, 1988.
